1. Name of the work: Construction of cement concrete -Sub-road of A-type quarter No. A-73 to A-77 and A-78 to A-79 at 43Km, NEEPCO Colony, RHPS, A.P. GROUP-V

- 2. Scope of the Work: The work to be executed as per Technical Specification attached in the tender document and as mentioned in the schedule of item enclosed in the tender document. Moreover, instruction of Site-Engineer is final and binding.
