Dear Sir,

The undersigned on behalf of “North Eastern Electric Power Corporation” (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) from experienced/reputed/preferably PLHPS registered contractors for execution of the following work. Terms & conditions are detailed herein under:

1. **Name of the work:** “Supply and engagement of 3(three) nos. of Skilled labours for monitoring of reservoir rim & intake water level at PLHPS, 41km, Arunachal Pradesh (Period 01.06.2024 to 31.03.2025)”
2. **Scope of the Work:** - The work to be executed as per Technical Specification attached in the tender document and as mentioned in the schedule of item enclosed in the tender document. Moreover, instruction of Site-Engineer is final and binding.
3. **Rate per unit basis:**
 - 3.1. Rate against each item shall be “FIRM” till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
 - 3.2. Bidders are to quote unit rates in figures and words for the items indicated in **Annexure-I** of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over writing, changes and cuttings shall be initialed by the bidders.
 - 3.3. **Taxes, Duties & Levies:** Bidders shall quote their rates against respective item specification inclusive of all taxes including GST, Building Cess and all charges etc. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work.
4. **Estimated Amount:**
 - 4.1 **Rs. 12,82,526/-** (Rupees twelve lakh eighty-two thousand five hundred twenty-six) only
 - 4.2 Building Cess, GST and other taxes & charges as applicable will be deducted from work value.
5. **Payment Terms:**
 - 5.1 Payment will be released after satisfactory completion of work as certified by the Engineer-In-Charge. No part payment/advance payment will be entertained.
 - 5.2 100% Payment will be released on successful completion of the work.
6. **Paying Authority:** The paying authority shall be the **Deputy General Manager (F), Head of the finance**, PLHPS, Yazali (A.P).

7. **Engineer-In-Charge:** The Engineer in charge shall be the **Senior Manager (C), R&B(M),** NEEPCO. Limited PLHPS, 43km Yazali.
8. **Time of Completion:** The work shall be completed within **01.06.2024 to 31.03.2025** from the date of issue of the Work Order.
9. **Compensation for Delay:**
In case of delay in work of items within the stipulated period indicated in **clause no.8** above, compensation for delay at the rate of 0.5% (zero point five percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of **10% (Ten percent)** of the contract price.
10. **Defect Liability Period:** Nil
11. **Security Deposit:** Nil
12. **Earnest Money Deposit :**

Earnest money Rs. 32,063/- (Rupees Thirty-Two thousand Sixty-Three only) and Rs.12,825/- (Rupees Twelve thousand Eight Hundred Twenty-Five only) for SC/St contractor shall be submitted in the form of Bankers cheque/Demand Draft duly pledged in favour of NEEPCO Ltd, Yazali, Keyi Panyor, Arunachal Pradesh. Our banker is S.B.I., Yazali 9917.PLHPS, non-submission of EMD, wherever applicable, shall result in cancellation of the bid document. However, firms/contractors registered in NEEPCO are exempted from submitting of earnest money along with tender in their respective class of registration.

13. Payment for online EMD through SBI Collect

STEP-1	Open https://www.onlinesbi.com
STEP-2	Click on SB Collect
STEP-3	Click to accept terms & condition and then click on "proceed to continue further"
STEP-4	Click Arunachal Pradesh in the drop down menu. Thereafter select "PSU-Public Sector Undertaking" then click on "Go"
STEP-5	Select "NORTH EASTERN ELECTRIC POWER CORPORATION" and click on "Submit"
STEP-6	Select "RHEP-PARTIES" in the drop down menu
STEP-7	Fill up the details a) Name b) In Short details write EMD/Tender Cost NIT No. (As applicable) c) Choose Vendor-- Click on "Submit to continue."
STEP-8	This screen shall lead to payment gateway from where SBI and other banks, Debit/ Credit Card and wallet etc. may be chosen by the vendor
STEP-9	After completion of the process a copy of the payment e-receipt may be taken and to be completed in the EMD/Tender cost attachment of the online bid.

14. Submission of Documents:-

- Copy of Income Tax PAN card.
 - Certified copy of registration with PLHPS, NEEPCO, Yazali (A.P) in case of PLHPS registered contractor.
 - Copy of Goods and Service Tax (GST) registration.

- b) Successful bidder has to submit the Certified copy of EPF registration under EPF&MP Act, 1952 with code number to capacitate for issuing of work order.

- c) Successful bidder will have to submit the following documents along with the final bill / Invoice for effecting e-payment.
- i) Name & complete address of your firm as per Bank record.
 - ii) Complete address of the Bank with branch details.
 - iii) Type of Bank account (Saving/current/Cash credit).
 - iv) Bank account number (indicating core Banking account number), if any.
 - v) IFS Code (11 digit)/MICR code as applicable.
- i) E-mail address of the vendor/authorized official along with mobile number (for receiving the update status of payment) if any.
