#### **TERMS & CONDITIONS:**

- 1. Scope of work: The work viz. "Upkeeping of 43Km NEEPCO colony, PLHPS, Arunachal Pradesh, from 01.06.2025 to 31.03.2026" is to be carried out as per the specifications mentioned in the BOQ enclosed as Annexure -I. The work is to be executed and completed as per direction of the Engineer -in- charge (EIC) i.e. Senior Manager(C),
- 2. Rate per unit basis:
- 3.1.Rate against each item shall be "FIRM" till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
- 3.2. Bidders are to quote unit rates in figures and words for the items indicated in Annexure-I of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over-writing, changes and cuttings shall be initialed by the bidder.
- 3.3. Taxes, Duties & Levies: Bidders shall quote their rates against respective item specification inclusive of all taxes including GST, Building Cess and any other charges etc. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by
- 3. Estimated Amount: Rs 1,17,29,665.00 (Rupees one crore seventeen lac twenty nine thousand six hundred and sixty five) only inclusive of all applicable taxes, cess etc..

5. Paying Authority: The paying authority shall be the Head of Finance / Sr. Manager (F), PLHPS, Yazali (A.P).

6. Engineer-In-Charge: The Engineer-In-Charge shall be Senior Manager (C) R&B (M), NEEPCO Ltd., PLHPS, 43 KM, Yazali, A.P.

7. Time of completion: - 304 (three hundred and four) days with effect from 01.06.2025 to 31.03.2026

8. Labour act and other relevant regulations: Strict adherence to all statutory labour rules, regulations, and amendments by the Govt. of India and State Govt. and should be complied by the contractor. The contractor himself will be responsible for compliance of the provision of the said act, as per Govt. notification. The contractor must be a registered establishment under the EPF &M.P. act 1952 and scheme thereunder and shall specify Independent Code No. All necessary/adequate personal safety measures/ requirements as per relevant safety engineering and safety codes shall be kept available at site. The contractor himself shall ensure proper use of the safety measures. The contractor shall be fully responsible for making arrangement against insurance of Labourers and materials to be engaged at site.

9. Compensation for Delay:

In case of delay in work of items within the stipulated period indicated in clause no.8 above, compensation for delay at the rate of 0.5% (zero-point five percent) of the contract price per week or part thereof of delay shall be deducted subject to a maximum of 10% (Ten percent) of the contract sum.

10. Defect Liability: Any defect in the work, detected during or after completion of the work during the contract period i.e. within 01.06.2025 to 31.03.2026, shall be made good by the Contractor at his own risk and cost and for this no extra payment shall be made by the Corporation. The nature and extent of defects, if any, and the liability period for the Contractor for making good the same shall be assessed and decided by the Engineer-in-Charge. The decision of the Engineer-in-Charge, in this regard shall be final and binding.
