03. **Delivery period** : For supply, commencement of AMC items should be supplied within (fifteen) days of issue of the order. For AMC the same will be commence immediately from the day of placing of the order.
04. **Earnest Money**: Bidders will have to deposit Earnest Money along with the offer in the form of Call Deposit @ 2%(Two Percent) of quoted value from any Nationalized/Scheduled Bank pledged in favour of "North Eastern Electric Power Corporation Ltd." and payable at Agartala.
05. **Certificate** : For supply/change of spares under AMC, the same should be accompanied by Company's authentication certificate/warranty card.
06. **Payment Terms** : For both supply and AMC 100% payment will be made after received of materials/commencement of AMC at our project site.


