- The list of Organizations certified by you for all of the above Standards, either together or separately should be submitted along with the bids..
- The validity of accreditation for all three standards shall be submitted along with supporting documents.
- The address of operational office nearest to Shillong /Tripura may be submitted.
- The offer must be accompanied by an Earnest Money Deposit (EMD) a) KHEP- Rs.2520.00, b) AGBPP - Rs.2340.00, c) AGTPP& CCEP – Rs.1890.00 and d) DHEP - Rs.1750.00 in the form of Account Payee Demand Draft in favour of NEEPCO Ltd. payable at Shillong. The EMD for the un-successful bidders shall be released immediately after finalization of the tender.
- Security Deposit (SD) :- The total security deposit will be considered as 10% of Work order value. Earnest Money Deposit (EMD) shall be retained by NEEPCO for the successful bidder as Security Deposit and balance amount of security shall be deducted from interim Running Account (RA) bill. The SD shall be released after the Completion of the successful certification period (i.e. after the completion of the second Surveillance audit.).No interest will be payable on the security deposit retained by NEEPCO.
- Your comprehensive offer for above-mentioned scope of works should be received in this office latest by **10.30 AM on 16th Dec'2015, 2015**. The offer shall be opened at 11.30 AM on 16th Dec'2015, 2015 in the office of the undersigned.
- In the event, the specified date for receipt and opening of bids is declared as a closed holiday for NEEPCO, the due date for submission of bids and opening of bids will be the following working day at the appointed times.
- The offer should be valid for six month from the date of submission of bid.
- The validity of Certification shall be 3 (three) Years.
- Completion time for issue of certificates:- Certificates for QMS, EMS and OHSAS are to be issued within 90 (sixty) days from the date of issue of the work order.
- There will be two numbers of periodic audits during the validity period of 3 (three) years.
- Free boarding and lodging for the visiting Auditors/Officials limited to maximum 2 (two) officials against successful bidders shall be provided by NEEPCO at project site either at NEEPCO Guest House or at Hotel.

13. Local transportation at Plant site shall be arranged by NEEPCO.
14. Penalty:- Penalty @ 0.5% (of the Certification Cost only) per week subject to ceiling of 10% will be levied by NEEPCO if the certification is not completed within the stipulated date. However this penalty clause would not be applicable if any major non-conformity report during Certification Audit is kept open.
15. Force Majeure:- Delay in or failure of performance of either party hereto shall not constitute a default hereunder or give rise to any claim for damage if and to the extent such delay or failure is caused by reasons such as Civil Strikes / Bandhs, acts of terrorism, Accidents, Flood etc., or due to Natural Calamities and any other reasons beyond the control of either parties.
16. Dispute Resolution:- This agreement shall be governed and construed in accordance within the laws of India. Any dispute arising in relation to or as a consequence of this agreement shall be restricted to the jurisdiction of the Hon'ble High Court of Shillong.

Payment Terms

- a) The quoted price shall be inclusive of all taxes or Levies etc. if any. No other claims whatsoever shall be entertained by NEEPCO.
- b) No advance payment shall be made.
- c) The above mentioned rates shall remain firm during the Certification period of three years.
- d) Registration & Certification Fee shall be released after receipt of certificates.
- e) Periodic (Surveillance) Audit fees:- The charges for Surveillance/Periodic Audit is payable proportionately only after completion of the said Audits.
- f) Traveling Expenses:- This shall be paid proportionately.

Issuance of bid documents shall not automatically construe qualification. NEEPCO reserves the right to reject any or all bids or to annul the bidding process and reject all the bids for any justified and genuine grounds, thereby without incurring any liability to the affected bidders, nor does it have any obligation to inform the bidders of the ground for the action of NEEPCO.
