# 1.0 QUALIFYING REQUIREMENT OF BIDDERS:

Prospective bidders, with similar nature of work experience, have to submit the following particulars.

- I. Experience of having successfully completed construction related works during last 7 years ending last day of the month previous to the one in which applications are invited should be either of the following:
  - a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost or
  - b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost or
  - c) One similar completed works costing not less than the amount equal to 80% of the estimated cost.
- II. Proof of document/documents must be submitted for **EMD concession**with the BID Document if applicable, otherwise Bidder will be chosen as General category.
- III. The bidder registered as Micro/ small Enterprise are exempted from paying applicable bid fee and earnest money deposit subject to submission of valid and relevant document/ certificate.
  The above experience should be with any Government department / PSU/Reputed Industry.
  Certificate in support of successful execution of work should be submitted.
- 1.1 Complete Audited Annual Reports along with Audited Balance Sheets, Profit and Loss Account and other financial statements for the preceding 3(three) financial years, ending 31st March of the previous Financial Year, along with Letter of adequacy/ solvency and commitment from their Bankers/Financial Institutions of International repute should be furnished along with their bids for evaluating the above financial criteria. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be considered acceptable.

#### 1.2 Bids submitted without fulfilling the qualifying requirements shall be rejected.

- 1.3 The bidders shall not anticipate change in the Ownership of their concern during the proposed period of work. If such a change is anticipated, the scope and effect thereof shall be defined.
- 1.4 Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by any bank.
