# Detailed Notice Inviting BIDs from prospective bidders (Domestic Competitive Bidding)

REPAIRING OF TWO NOS. OF BUTTERFLY VALVES IN THE VALVE HOUSE OF 4 X 50 MW KOPILI POWER STATION AT KHEP, NEEPCO LTD., UMRONGSO, ASSAM

North Eastern Electric Power Corporation Ltd., (NEEPCO), a Public Sector Enterprise under the Ministry of Power, Government of India, invites sealed bids with 120days validity from prospective experienced bidders under the Single-Stage Two-Envelope bidding system through Domestic Competitive Bidding (DCB) route for awarding the contract of "Repairing of two nos. of Butterfly Valves in the Valve House of 4 X 50 MW Kopili Power Station" of Kopili Hydro Electric Plant , NEEPCO Ltd. , Umrongso , Dima Hasao ,Assam.

# **DETAILS OF THE NIT:**

# 1.0 QUALIFYING REQUIREMENT OF BIDDERS:

The bidder shall provide satisfactory evidence concerning the following:

#### 1.1 **Technical:**

- i) The intending bidder should have experienced in following works
  - a) Execution of " Dismantling including repairing / overhauling and reassembling of BF valve of minimum dia. 2 (two) meter".
  - b) Execution of "Repairing of under water turbine parts/ equipment by means of Weld build up of eroded portion, Cladding, Machining & Grinding etc.".

    OR

Execution of similar nature of works consisting of "Fabrication, weld build up of eroded portion, cladding, machining & grinding etc".

The above experience should be with any Government department / PSU/IPP (**Independent Power Producer**).

However, the work order copies / experience certificate issued by any Private firm must be supported by TDS certificate issued against the respective work order/contract.

Also, bidder shall submit certificate / documentary evidence in support of successful completion of work.

- ii) Similar works should have been carried out by the intending bidder in the last 7( seven ) years as follows:
  - (a) At least 3 (three) completed similar works, each of value of Rs.24,00,000/- or higher. OR
  - (b) At least 2 (two) completed similar works, each of value of Rs. 36,00,000/- or higher. OR
  - (c) At least 1(one) completed similar work of value of Rs. 48,00,000/- or higher.

Similar works shall mean:

 Dismantling including repairing / overhauling and reassembling of Butterfly valve or Spherical Valve. The type of repairing work should include weld buildup, cladding etc.

#### 1.2 Financial:

#### (a) Minimum Average Annual Turn Over (MAAT):

The average annual turnover of the bidder in the best 3(three) financial years out of the last 5 (five) years financial year should not be less than Rs. 12000000/- (Rupees One Crore Twenty Lakh).

- (b) Complete Audited Annual Reports along with Audited Balance Sheets, Profit and Loss Account and other financial statements for the preceding 3(three) financial years, ending 31<sup>st</sup> March of the previous Financial Year. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be considered acceptable.
- (c) Letter of adequacy/ solvency and commitment from their Bankers/Financial Institutions should be furnished along with their bids.

Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 1.0 above shall be submitted along with the containing Techno-Commercial bid along with Bid Guarantee. For qualifying requirements specified at Para 1.1 & 1.2 above, the documents should be in the form of Certificate of Clients/Owners. Bids submitted without fulfilling the qualifying requirements shall be rejected.

- 1.3 The bidder shall furnish copies of the following Registration Certificates
  - (a) Registration for Service Tax
  - (b) Registration for Sales Tax ( CST & VAT )
  - (c) PAN (Permanent Account Number) for Income Tax
- 1.4 The bidders shall also provide satisfactory evidence with respect to the following:
  - a. They do not anticipate change in the ownership of their concern during the proposed period of work. If such a change is anticipated, the scope and effect thereof shall be defined.
  - **b.** They have adequate financial stability and status to meet the financial obligations pursuant to the scope of the works.
  - c. The bidder shall submit copies of their audited Annual Reports and Balance Sheet for the last 3 (three) years, the latest Sales Tax Clearance Certificate/R Sales Tax Return and latest Banker's certificate indicating amount in support of solvency.

In case bidders are unable to furnish such certificates, they shall give valid reason for the same. The Owner reserves the right to reject any bid for the reason of the bidder's inability to furnish such certificate is not mentioned in the bids.

- 1.5 In addition, bidders shall satisfactorily establish that they fully meet the qualifying requirements specified in the accompanying Technical Specifications. This is essential for consideration of bidders' proposal.
- 1.6 Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by any bank.
- 1.7 The above requirements are minimum and the Corporation reserves the right to request for any additional information and also reserves the right to reject the proposal of any bidder if, in the opinion of Owner, the qualification data furnished by the bidder is incomplete or the bidder is found to be not qualified to satisfactorily perform the works.
- 1.8 Notwithstanding anything stated above, the Corporation reserves the right to assess bidders' capability and capacity to perform the work, should the circumstances warrant such an assessment, in the overall interest of the Owner.
- 1.9 Each bidder shall submit only 1 (one) bid, either individually. A bidder who submits or participates in more than 1 (one) bid will be disqualified
