Sealed tender with minimum 120 days validity are invited for selling of scrap from Kopili Hydro Electric Plant , NEEPCO Ltd. ,Umrongso, Dima Hasao District , Assam as per the following terms and conditions:

Terms and Conditions:

- Scope of work: Selling of 20 (twenty) Metric Ton of scrap and other miscellaneous items of Kopili Power Plant, NEEPCO Ltd., Umrongso, Dima Hasao District, Assam, PIN:788931. The materials shall be lifted from the Central Store of KHEP, NEEPCO Ltd. in presence of the Engineer –in-charge appointed or his representative on presentation of documentary evidence towards make of full payment for the scrap.
- Price Basis: The Price shall be quoted on FOR Umrongso basis inclusive of all taxes and duties as per the list enclosed "Annexure-I". The quoted price for lifting of scrap and miscellaneous items shall remain FIRM till completion of work.
- 3. Payment Terms: 100% of the quoted value in the form of Demand Draft drawn in favour of NEEPCO Ltd. payable at SBI, KHEPA, Garampani Branch, P.O. Umrongso (SBI Code-4812) shall be deposited by the successful bidder to the O/o the Manager (Finanace), KHEP, NEEPCO Ltd. Umrongso within 15 days from the date of issue of the formal order. No payment shall be received by the Corporation on installment basis
- Handling & Transportation: All handling, loading, transportation charges and other incidencial charges shall be borne by the successful bidder. For taking the equipments out from the Corporation's premises, Gate Pass will be issued by the Sr. Manager (Security), KHEP, Umrongso.
- The Corporation shall not responsible for any claims for contractor's labour. The contractor shall wholly or fully responsible for such claim for compensation either for accident or injury, death or damage caused to their employees/ transport during the lifting / handling of the materials inside the corporation premises.
- The contractor shall abide the Central / State labour Legislation as may be applicable from time to time.
- 7. <u>Delivery schedule</u>: The scrap shall be lifted by the successful bidder at his own cost within 15 days from the date of payment and necessary clearance by the Sr. Manager (E), Central Store, KHEP, Umrongso or his authorized representative. The delivery clearance shall be issued on proof of payment.
- The materials which are to be disposed shall be disposed as per rule of Assam Pollution Control Board. NEEPCO has no responsibility after the scrap and miscellaneous items are disposed by the contractor/firm.

GENERAL INSTRUCTION TO BIDDERAND COMMERCIAL REQUIREMENT

- 1.0 The bidder shall read the general instruction thoroughly and quote accordingly along with the requisite documents where asked. Every page of the Tender Documents shall be signed by the intending bidder as a token of acceptance of terms and conditions contained in the Tender Documents.
- 2.0 Intending bidders may contact the Sr. Manager, Central Store, KHEP, NEEPCO Ltd., Umrongso on any working day for inspection of scrap.
- 3.0 Earnest Money: Intending Bidder shall submit Earnest Money for an amount of Rs 10000.00 (Rupees ten thousand) only for general and Rs 5000.00 (Rupees five thousand) only for SC/ST/KHEP affected in the form of Bank Draft/Demand Draft



in favour of NEEPCO Ltd, KHEP, Umrongso payable at SBI, KHEPA(Garampani) Branch. The tender shall be liable for rejection in case of the EMD of requisite value is not found alongwith the tender. EMD shall be refunded to the respective bidder after award of contract to the successful bidder.

- 4.0 <u>Tender free</u>: Tender free Rs 1000.00 (non refundable) in the form of banker cheque /DD drawn in favour of NEEPCO Ltd, Umrongso have to be submitted along with the offer.

- 6.0 <u>Date & time for opening the Tender</u>: The bids will be opened at the time and date mentioned below in presence of authorized representative (if any) of the bidders. No electronic recording device will be permitted during opening of the bids.
