3. **Payment:** 100% payment shall be made after receipt of the materials at site in full and good condition.
4. **Delivery:** The materials shall be delivered at site within **45 days** from the date of issue of formal order.
5. The successful bidder shall supply the materials to the satisfaction of Engineer-in charge. Defective materials shall be replaced by the supplier at free of cost immediately on intimation.
6. **Submission of Bid:**

- 6.2 A signed copy of the tender specification (detailed NIT) must be submitted along with the bid in acceptance of NIT conditions. The tender specification may be downloaded from Corporation website www.neepco.gov.in.

7. The bids will be opened at the time and date mentioned below in presence of bidder or his authorized representative (if any). No electronic recording device will be permitted during opening of the bids.

i) Last Date and Time of receipt of the bids : 15-00 hrs of 02-12-2015

ii) Date and time of opening of bids : 15-30 hrs of 02-12-2015

In the case of any bandh / holidays on the above mention date, the bid will be received and opened in the next working day at the same time as indicated above. No telex / fax / Telegraphic tender will be received.

8. **Earnest Money Deposit:** EMD @2% of the quoted value in the form of **Demand Draft** duly pledged in favour of NEEPCO Ltd., payable at SBI, KHEPA, Garampani Branch, P.O. Umrongso (SBI Code-4812) should be submitted along with the tender. Tender without EMD shall be rejected.

a. EMD submitted by the successful bidder shall be retained as security deposit towards satisfactory execution of the order and will be released after delivery of entire quantity.

b. EMD of the unsuccessful bidders will be returned only after finalization of the bid.

9. All rates and amount of the bid shall be legibly written in both figure and words. In case of any discrepancy between figure and words, the amount indicated in the words will be considered.

10. **Tender Fee:** Tender fee 1000.00 (non-refundable), in the form of Banker's Cheque / Demand Draft drawn in favour of NEEPCO Ltd. Umrongso, have to be submitted along with the quotation.

11. **Additional Documents :**

The following documents should be submitted along with the bid in order to ensure qualification:

a) Copy of PAN / GIR card.

b) Valid Contract licence.

c) VAT Registration.

d) Copy of the Service Tax registration certificate, if applicable.


