#### 1. SCOPE OF SUPPLY / WORKS: Scope of work shall include

- a) Manufacture, Testing, Supply of M/s Megger make Tan Delta test kit Model no. DELTA4110 with accessories and commissioning of Test Kit at Assam Gas Based Power Plant, NEEPCO Ltd., Bokuloni, Dibrugarh, Assam, Pin– 786 191 as per Technical Specifications detailed in Annexure-1.
- **b)** The supplier shall supply any special tools and tackles required for day-to-day maintenance and on site servicing of the test kits and accessories free of cost.
- c) The supplier shall provide 3 sets of first time consumables (e.g. fuse etc.) along with the supplied materials free of cost.
- d) The supplier shall arrange a free training programme on usage of the test kit.

The supplier/contractor can make assessment of the work by visiting our site at AGBP. The contract includes all work as a complete package, as per "Schedule of Requirement".

# 2. QUALIFYING REQUIREMENTS FOR BIDDERS A. TECHNICAL REQUIREMENT

- I. The bidder should be an Original Equipment Manufacturer (OEM) or Authorized Dealer of the OEM. In case of being Authorized Dealer of the OEM, the Bidder should enclose valid authorization certificate duly authorized by the OEM.
- II. The bidder must have experience and past performance on similar contract satisfactorily at least for last 2 years. i.e. Supply, Testing and Commissioning of Tan-Delta Test Kit (M/s Megger make) in any PSU/govt. (either central or state) organization or any reputed organization in India. The bidder should furnish copies of the certificate with detailed orders and also performance certificates from the customer.

- III. The bidder should have well established after sales service/authorized service set up/service centre in the North East India and availability of technical man power so that technical help can be availed at shortest notice. Details of after sales service/authorized service set up/service centre indicating complete address and contact details shall have to furnish.
- IV. The bidder shall not have been blacklisted by any Government/ Government agency in India. Self declaration to that effect should be submitted along with the technical bid
- V. Bidder's organizational strength and financial status, annual report (balance sheet and profit & loss account) of last three years shall have to furnish.

#### **B. COMMERCIAL REQUIREMENT**

- I. **PRICES:** The rates quoted shall be FIRM for the validity period of the tender, i.e. upto 180 (one hundred eighty) days (including 180th day) from the date of opening of the Techno Commercial bid.   - IX. <u>DELIVERY & COMMISSIONING PERIOD:</u> The entire works are to complete within 60 (Sixty) days from the date of placement of work order. The bidder shall provide actual requirement of delivery period as per the 'Schedule of Deliveries & Commissioning period (Annexure-8)'
  - X. **TRANSPORTATION:** All transportation charges and any octroi/ entry tax shall be in the supplier's scope. Transit insurance shall be in supplier's scope and the supplier shall arrange for and take full responsibility during transit and comply with necessary safety measures as called for relevant Act/Regulations.
