- B. <u>GENERAL TERMS & CONDITIONS:</u>
- **O1**. **Scope**: Supply, transportation, transit insurance, loading & unloading of materials and delivery up to AGTCCPP. Bidders should mention the make of offered materials.
- **O2**. **Delivery & delivery point**: All the materials shall be delivered within 30 (Thirty) days to the address of the consignee from the date of receipt of the formal order.
- 03. Liquidity Damage: If the materials not supplied within the stipulated time a Liquidity Damage shall be applicable @  $\frac{1}{2}$ % (Half percent) of the total value of the undelivered items per week subject to a ceiling of 10% of the ordered value.
- **O4.** Rate: Bidder shall quote unit as well as total item wise prices for the materials. Rates should be quoted both in figure and words. In case of any discrepancy between figures and words, the amount indicated in words will be considered. In case of any discrepancy between "unit rate" and "total amount" the total amount evolved by multiplying the unit rate and quantity shall be considered.

The bidders shall fully make himself aware of the applicable taxes & duties for supply of goods at Tripura & submit total FOR AGTCCPP prices showing break-up of basic price, applicable taxes & duties, freight & insurance charges. If no break-up is given, it will be considered that the quoted price is FOR destination price inclusive of all taxes & duties. In that case all the applicable taxes & duties levied during the supply of the material shall be borne by the supplier.

All prices shall remain firm till completion of the supply. For concessional CST, "C" Form shall be issued.

- O5. Earnest Money: An amount Rs. 4200.00 (Rupees Four thousand Two hundred) only shall be deposited as earnest money in the form of Call Deposit/ Demand Draft/ Bankers Cheque from any Nationalized Bank pledged in favour of North Eastern Electric Power Corporation Ltd., failing which their quotation shall not be considered. If a bidder withdraws the tender while it is under construction or after placement of order, his bid security/EMD shall be forfeited along with other action, as the Corporation deems fit. The EMD shall be made payable without any condition to Purchaser .The EMD of all unsuccessful bidders shall be returned only after placement of order with the successful bidder.
- 06. Payment: 100% (Hundred percent) payment shall be released after receipt of the materials in full and good condition and after necessary physical inspection and acceptance of the materials at our store, against submission invoice in triplicate along with all related document as required . For effecting E- payment you are requested to submit the bank details for NEFT/RTGS.

- **O7**. **Warranty**: The products supplied must be warranted against manufacturing defect and shall be guided by manufacturer's **warranty** clause. Damaged/defective items on receipt at store shall be liable for rejection and replacement thereof.
- O8. Last Date and Place for submission of Bid: The bidder shall submit their Quotation and EMD in a Sealed Envelope. These shall be received till 13:00 hrs. of 16-01-2016 at O/O the Sr.Manager (E/M), C & P Cell, AGTCCPP, NEEPCO and shall be opened at 15:00 hrs. of the same day i.e. on 16-01-2016. In case 16-01-2016 is a holiday, the Quotation shall be opened on the next working day at 15:00 hrs.
- **09**. If the bidder is eligible for any kind of exemption/concession from state Govt. /Central Govt. the bidder shall furnish documentary evidence to consider the same.
- 10. QUANTITY: The Quantity mentioned above may increase or decrease.
- 11. While submitting the bids the "check list for submission of bids" shall be strictly followed. Duly filled up copy of the same shall be placed along with the bids.
