Notice Inviting Tender No. – RHEP/C&P/06 /2021-22

The undersigned, on behalf of the Corporation hereby invites online bids under Single stage Two Envelope system through Domestic Competitive Bidding (DCB) route with a validity of 180 (One Hundred Eighty Days) from Authorized dealers of electrical items for “Supply of Electrical Consumables for Ranganadi H.E. Plant, NEEPCO, Arunachal Pradesh”, as detailed herein under::

1. SCOPE:

The scope of work shall be “Supply of Electrical Consumables for Ranganadi H.E. Plant, NEEPCO, Arunachal Pradesh” as per BOQ and delivery of same to Central Store, RHEP, NEEPCO, Yazali, Lower Subansiri Dist, Arunachal Pradesh. The terms and conditions governing this tender are detailed in the subsequent sections of the Bid Document. The details of supply of the items required, is given as **Annexure – A**.

2. COMPLETION TIME:

The delivery period of materials shall be **45 (forty-five)** Days from the date of issue of detail Supply order.

3. QUALIFYING REQUIREMENT:

a) TECHNICAL: The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.

- (i) Trade License of the firm in case of reputed firms showing his credential as a supplier of Electrical Consumable Materials.
- (ii) Certificate of incorporation in case of a company, partnership deed in case of a partnership firm as the credential of the firm.
- (iii) The bidders shall attach the following in support of his credentials:
 - (a) Authorized Dealership - Valid Dealership certificate of the brand of the cables proposed to be supplied.
 - (b) Authorized Dealership/ authorization by OEM (BAJAJ) – Valid Dealership/ authorization by OEM (BAJAJ) against LED luminaries to be supplied as given in the BOQ.
- (iv) The bidder shall have executed/supplied Electrical Consumable materials to any Govt. /PSUs organizations in the order as specified below:
 - (a) A single order of not less than ₹. 23.55 lacs executed by the firm in the last 03(three) years and the bidder shall submit the copy of the said supply order.
Or
 - (b) Two orders of not less than ₹. 17.66 lacs each executed by the firm in the last 03(three) years and the bidder shall submit the copies of the largest supply orders or.
 - (c) Three orders of not less than ₹. 11.77 lacs each executed by the firm in the last 03(three) years and the bidder shall submit the copies of the largest supply orders.

- (v) Copy of provisional/ migrated GST ID, PAN number, Bank account No (along with IFSC code) number should be submitted along with the Bid. The documents submitted in support of the credential should be valid till the opening of the Bid as specified in the Tender.

b) FINANCIAL:

The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.

- (i) Annual turnover by the firm in the best three financial years out of last five financial year ending March 2021 should not be less than ₹. 58.87 Lacs.
- c) Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 3.0 above shall be submitted online along with the Techno-Commercial bid under Envelope – I. Bids submitted without fulfilling the qualifying requirements shall be rejected.
- d) The above requirements are minimum and the Corporation reserves the right to request for any additional information and also reserves the right to reject the proposal of any bidder if, in the opinion of owner, the qualification data furnished by the bidder is incomplete or the bidder is found to be not qualified to perform the work satisfactorily.
- e) Notwithstanding anything stated above, the Corporation reserves the right to assess bidders' capability and capacity to supply the item, should the circumstances warrant such an assessment, in the overall interest of the Owner.
- f) Each bidder shall submit only 1 (one) bid. A bidder who submits or participates in more than 1 (one) bid will be disqualified.
- g) If an agent submits bid on behalf of one manufacturer/ dealer, the same agent shall not submit a bid on behalf of another manufacturer/dealer in the same tender.

4. E-TENDERING / E-PROCUREMENT:

This tender is being processed through e-tendering/e-procurement system. The bidding documents are to be downloaded, filled in bids are to be uploaded through e-tendering system of NEEPCO Ltd. at <https://etenders.gov.in> .

5. PARTICIPATING IN THE BID:

5.1 Portal Registration:

The bidders intending to participate in the e-tendering and download the detailed bid document have to register themselves in the portal <https://etenders.gov.in> . Relevant information about the bidder required during the registration is available in the portal.

5.2 Vendor registration : Vendor Registration in the portal is free of charges. The details of registration procedure is available on the web site <https://etenders.gov.in/eprocure/app> under category “Downloads” . The details is also given under Section-II ' Instruction to Bidders' as Annexure-B ('Instruction for online Bid Submission').

6. PROCEDURE FOR PAYMENT OF BID FEES & EMD:

6.1 Bid Fees

- a) Bidder shall make payment of non refundable Bid fees of amount ₹. 1180/- (**Rupees One Thousand One Hundred Eighty**) only inclusive of GST @18% online through “SB Collect” details of which is given in the Section-II **Instruction to Bidders at Sl. No. 8.1**. A copy of payment receipt to be uploaded in the e-tendering site falling which the bid shall not be considered. Further Documentary evidence of the Bid Fees paid shall accompany the Technical Bid. The invoice against the Bid Fee shall be submitted to the bidder after opening of the e-tender.

- b) Bids received online without Cost of Bid Documents unless exempted shall be rejected.
- c) **Please ensure that payment of Bid Fee is made under “RHEP PARTIES” only in SB Collect.**
- d) Payment of bid fee in any other mode will not be accepted.

6.2 EMD

- a) Bidder shall make payment of refundable EMD of amount ₹ 59,000/- (**Rupees Fifty Nine Thousand**) only online through “SB Collect” details of which is given in the section **Instruction to Bidder at Sl. No. 8.1**. A copy of payment e-receipt to be uploaded in the e-tendering site falling which the bid shall not be considered.
- b) Bids received online without EMD unless exempted shall be rejected.
- c) **Please ensure that payment of EMD is made under “RHEP PARTIES” only in SB Collect. Payment of EMD in any other mode will not be accepted.**

7. **EXEMPTIONS FOR MSME’s.**

- 7.1 Exemptions for MSME’s shall be applicable under the Govt. of India norms under PPC guidelines.
- 7.2 Also the Price preference as applicable to MSME’s as per Govt. of India Norms, during evaluation of the Bid shall be applicable. A copy of the MSME registration is to be submitted along with the Techno-Commercial Bid.
- 7.3 **It may kindly be noted that MSME exemptions or price preferences shall only be applicable to firms which are registered as MSME units dealing with manufacture or selling of electrical items/equipments/consumables.**
