DETAILS OF THE NIT:

- 1. SCOPE OF WORK: The scope of work covered under this tender for "
 - (i) Hacking of existing mosaic flooring and dismantling of existing mosaic wall skirtings the Technical Section of ED(P)-Hydro Office and Finance Wing, Guwahati
 - (ii) Providing vitrified floor tiles on the floors and wall skirtings of the Technical Section of ED(P)-Hydro Office and Finance Wing, Guwahati including necessary cement plastering works
 - (iii) Cleaning and painting the internal wall surfaces, celling and wooden surfaces of doors and windows of the Technical Section of ED(P)-Hydro Office and Finance Wing, Guwahati
 - (iv) Providing new flush doors of the Technical Section of ED(P)-Hydro Office and Finance Wing, Guwahati

The detailed Scope of Works shall be indicated in the relevant Technical Specifications mentioned in the Bill of Quantities.


2. QUALIFYING REQUIREMENT OF BIDDERS:

The bidder shall provide satisfactory evidence concerning the following:

Technical: Prospective bidders have to submit the following particulars with similar nature of work experience are: -

- (i) Average annual turnover during the last 3(three) years ending 31st March of the previous financial year should be at least 30% of the estimated cost.
- (ii) Experience of having successful completion of similar nature of works during last 3(Three) years ending last day of the previous month should be either of the following: -
 - (a) At least 3(three) similar completed works costing not less than the amount equal to 40% of the estimated cost in each work. Or,
 - (b) At least 2(two) similar completed works costing not less than the amount equal to 50% of the estimated cost in each work. Or,
 - (c) At least 1 (One) similar completed works costing not less than the amount equal to 80% of the estimated cost in each work.

The above experience should be with any Government Department/PSU/Government Autonomous Body, Certificate in support of successful execution of work should be submitted. "Similar nature of works" shall mean vitrified tiles work, cement plastering, wooden doors, painting works etc.

4. CREDENTIALS OF BIDDERS:

Bidders are to submit the following particulars along with the detailed Bid Documents in support of the Qualifying Requirements.


- i) Documentary evidence of Registered Entity in India /Company or Partnership company.
- ii) Documentary evidence of EPF registration and payment of EPF contribution against employees regularly.
- iii) Documentary evidence of Registration under ESI act, 1948.
- iv) Documentary evidence of GST Registration certificate along with GST Return (GSTR 1/GSTR 3B/GSTR 9 etc.).
- v) Documentary evidence of registration with Department of Labour.
- vi) Copies of latest Income Tax Clearance Certificate and PAN card.
- vii) Copies of experience in this field.
- viii) Documentary evidence in respect of annual turnover for last 3(three) years.
- ix) The Bidder participating as Micro / Small Enterprises (MSE) shall submit valid document.
- x) The MSE's who have applied for registration or renewal of registration with authorized agencies / bodies, but have not obtained the valid certificate as on close date of tender, are not eligible for exemption /preference.
- xi) The MSE's registered agencies / bodies are exempted for payment of BID FEES and EARNEST MONEY DEPOSIT (EMD).
- xii) Security Deposit: 10% (Ten percent) of the work value shall be retained as security deposit and the same shall be released after expiry of defect liability period or completion of defect rectification work if any arises or whichever is later.

5. Submission and opening of Bids:

a. Submission of bids: Bidders shall submit the documents mentioned in Clause No-4 in offline mode.

Documents to be submitted in offline/online mode as specified above in Clause No-4 shall be contained in a sealed envelope and the same shall be submitted by the Bidder duly marking these envelope as "Providing floor tiles on the Technical Section of ED(P)-Hydro Office and Finance Wing at Ground Floor of NEEPCO Bhawan, Guwahati" along with the identification No. of NIB. Any lack of knowledge to this effect on the part of the Bidder shall not entitle the contractor for any claim whatsoever and shall not be considered a cause of delay. The Tenderer are therefore once again advised to inspect the entire working front and make proper planning before submission of Tender.
- f. The tender should be submitted in the prescribed form and the same should be signed properly as laid down here under:
- g. If the tender is submitted by any individual, it shall be signed by the proprietor above his full name and full name of his firm with its current business address.
- h. If the tender is submitted by a firm in partnership, it shall be signed by all the partners of the firm above their full names and current business address, or by a partner holding the Power of Attorney for the firm and signing the tender in which case certified copy of the partnership deed and current business of all the partners of the firm shall also accompany the tenders.

If the tender is submitted by a limited company or a limited corporation, it shall be signed by a duly authorized person holding the Power of Attorney for signing the tender in which case a certified copy of the Power of Attorney may be required to furnish with satisfactory evidence of its existence before the contract is awarded.
