The undersigned on behalf of "North Eastern Electric Power Corporation" (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) from Panyor Lower Hydro Power Station (PLHPS) NEEPCO registered contractors of Hoj for execution of the following work. Terms & conditions are detailed herein under:

- 1. <u>Name of the work</u>: Construction of Rail cum Road and Foundation for Spare Reactor at 400kV GIS Extension Bay at 3X135 MW Panyor Lower Hydro Power Station (PLHPS), NEEPCO Ltd., Hoj, Arunachal Pradesh, India.
- 2. <u>Scope of the Work: -</u> The work to be executed as per Technical Specification attached in the tender document and as mentioned in the schedule of item enclosed in the tender document.

3. Rate per unit basis:

- 3.1. Rate for the scope of work of respective item against specification shall be "FIRM" till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
- 3.2. Bidders are to quote unit rates in figures and words for the items indicated in **Annexure-I** of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail, and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over writing, changes and cuttings shall be initialed by the bidders.
- 3.3. <u>Taxes, Duties & Levies</u>: Bidders shall quote their rates against respective item specification inclusive of all taxes. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work.

4. Estimated Amount:

- 4.1 ₹.29,49,625.00/- (Rupees Twenty-Nine Lakhs Forty-Nine Thousand Six Hundred and Twenty-Five) only.
- 4.2 GST and other taxes & charges as applicable will be deducted from work value.

5. Payment Terms:

- 5.1 Payment (Running Interim/Final) will be released after satisfactory completion of work as certified by the Engineer-In-Charge. No advance payment will be entertained.
- 5.2 97%(Ninety Seven percent) Payment will be released on successful completion of the work. Balance 3% will be kept as Performance Guarantee, which will be released after expiry of defect liability period for the Work. In case of any defect in the work detected after the completion of the work within the defect liability period, shall be made good by the contractor at his own risk and cost, and no extra payment shall be made by the corporation.
- 6. Paying Authority: The paying authority shall be Manager (F), PLHPS, NEEPCO Ltd., Yazali (A.P).
- 7. <u>Time of Completion</u>: The work shall be completed within 45(Forty Five) days from the date of issue of work order or handing over of site.

8. Compensation for Delay:

In case of delay in work of items within the stipulated period indicated in clause no.7 above, compensation for delay at the rate of 0.5% (zero-point five percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of 10% (Ten percent) of the contract price.

9. Defect Liability Period:

The works shall be subjected to a defect liability period of **12** (**Twelve**) **months** from the date of completion of work in all respect. The nature and extent of defects to be considered for the purpose of Defect Liability, shall be decided by the Head of Project/Engineer-In-Charge and decision of Head of Project/Engineer-In-Charge in this matter shall be final and binding. On expiry of defect liability period a Certificate in this regard shall be issued by the Engineer-in-charge. In case of noncompliance of clause, no 5.2 the security deposit shall be forfeited.

10. Security Deposit:

3% (Three percent) of the work value shall be retained as security deposit and the same shall be released after expiry of defect liability period or defect rectification work if any arises whichever is later.

11. Exemption for MSME registered Firms:

Exemption for MSME's shall be applicable under the Govt. of India norms under PPC guidelines.

12. Earnest Money Deposit:

Earnest Money ₹.73,741.00 (Rupees Seventy Three Thousand Seven Hundred Forty One) only for General Contractors/Firm & ₹. 29,496.00 (Rupees Twenty Nine Thousand Four Hundred Ninety Six) only for SC/ST contractor shall be submitted through SB collect. Steps for SB collect.
