Dear Sir,

The undersigned on behalf of “North Eastern Electric Power Corporation” (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) from experienced/reputed/preferably PLHPS registered contractors for execution of the following work. Terms & conditions are detailed herein under:

1. **Name of the work:** “Civil maintenance work of Dam and Intake site, PLHPS , 41km, Arunachal Pradesh”
2. **Scope of the Work:** - The work to be executed as per Technical Specification attached in the tender document and as mentioned in the schedule of item enclosed in the tender document. Moreover, instruction of Site-Engineer is final and binding.
3. **Rate per unit basis:**
 - 3.1. Rate against each item shall be “FIRM” till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
 - 3.2. Bidders are to quote unit rates in figures and words for the items indicated in **Annexure-I** of tender document. The tendered amount shall be legibly written in English in ink, in Indian

currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over writing, changes and cuttings shall be initialed by the bidders.

3.3. **Taxes, Duties & Levies:** Bidders shall quote their rates against respective item specification inclusive of all taxes including GST, Building Cess and all charges etc. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work.

4. **Estimated Amount:**

4.1 **Rs. 22,71,469.00** (Rupees Twenty-Two lakhs Seventy-One thousand four hundred Sixty-Nine) only

4.2 Building Cess, GST and other taxes & charges as applicable will be deducted from work value.

5. **Payment Terms:**

5.1 Payment will be released after satisfactory completion of work as certified by the Engineer-In-Charge. No part payment/advance payment will be entertained.

5.2 **90%** Payment will be released on successful completion of the work. Balance **10%** will be kept as Security deposit, which will be released after expiry of defect liability period for the Work. In case of any defect in the work detected after the completion of the work within the defect liability period, shall be made good by the contractor at his own risk and cost, and no extra payment shall be made by the corporation.

6. **Paying Authority:** The paying authority shall be the **Manager (F)**, PLHPS, Yazali (A.P).

7. **Engineer-In-Charge:** The Engineer in charge shall be the **Deputy General Manager(C)**, HS(M), NEEPCO. Limited PLHPS, 43km Yazali.

8. **Period of the work:** The work shall be Started from **1st August 2023 to 31st March 2024**.

9. **Compensation for Delay:**

In case of delay in work of items within the stipulated period indicated in **clause no.8** above, compensation for delay at the rate of 0.5% (zero point five percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of **10% (Ten percent)** of the contract price.

10. **Defect Liability Period:** The nature of work is such that there is no liability period.

11. **Security Deposit:** Nil.

12. **Earnest Money Deposit :**

Earnest money Rs **56,787.00**. (Rupees *Fifty-Six Thousand Seven Hundred Eighty-Seven*) only for general contractors/firm & **22,715.00** (Rupees *Twenty-Two Thousand Seven Hundred Fifteen*) only for SC/St contractor shall be submitted in the form of Bankers cheque/Demand Draft duly pledged in favour of NEEPCO Ltd, Yazali ,Lower Subansiri, Arunachal Pradesh. Our banker is S.B.I. ,Yazali 9917.PLHPS,non-submission of EMD ,wherever applicable , shall result in cancellation of the bid document. However, firms/contractors registered in NEEPCO are exempted from submitting of earnest money along with tender in their respective class of registration.

13. **Submission of Documents:-**

ii) **Certified copy of registration with PLHPS, NEEPCO, Yazali (A.P) in case of PLHPS registered contractor.**

- c) Successful bidder will have to submit the following documents along with the final bill / Invoice for effecting e-payment.

 - ii) Complete address of the Bank with branch details.
 - iii) Type of Bank account (Saving/current/Cash credit).
 - iv) Bank account number (indicating core Banking account number), if any.
 - v) IFS Code (11 digit)/MICR code as applicable.
- i) E-mail address of the vendor/authorized official along with mobile number (for receiving the update status of payment) if any.

14. Terms & Condition for Submission of Tender:

- (i) Non-transferable Bid documents can be obtained from the Office of the General Manager (C), PLHPS, NEEPCO, Yazali, Arunachal Pradesh from **18.07.2023 to 17.08.2023** in any working days between 11:00 hours to 13:00 hours.
- (ii) Last date of submission of bid: On **18.08.2023** up to **13:00** hours at office of the General Manager (C). PLHPS, NEEPCO. Limited, Yazali, A.P.
- (iii) Date of opening of bid: On **18.08.2023 at 15:00** hours in the office of the General Manager (C). PLHPS, NEEPCO. Limited, Yazali, A.P.
- (iv) Sealed Tender is to be submitted to the undersigned either in person or by speed post as per the following:

- (vi) Validity of bid : **180** (One Hundred Eighty) days.

- (viii) Tender will be opened in the presence of Bidder or his authorized representative who chooses to attend on the specified date and time.
- (ix) In the event of the date specified for bid receipt and opening being declared as a closed holiday for Purchaser's office, the due date for submission of bids and opening of bids will be the following working day at the appointed time and place.
- (x) Tenders received by Fax or E- mail shall not be accepted.
- (xi) The Corporation cannot be held responsible for non-receipt and Postal delay.
- (xii) The Corporation reserves the right to accept or reject any or all tenders in part or full without assigning any reasons thereof and is not bound to accept the lowest bid.

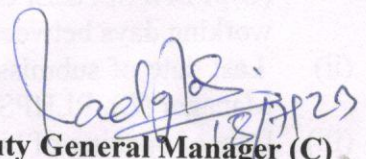
