North Eastern Electric Power Corporation Limited invites sealed Request for Proposal (RFP) / Bids with 180 (one hundred eighty) days validity from reputed Firm/ Vendor/ Supplier / Dealer / Manufacturer for 'Design, supply, manufacture, delivery, installation, etc. complete in all respect including supply of materials for the items as listed in Annexure-I for their Guest House at Tuirial Hydro Power Station, Mizoram'. Base specifications for the desired furnishing are described in Annexure-I. Floor plans of the GH is attached in Annexure-II. Typical Sketch & Sample Photos are attached in Annexure-III.

If a vendor wishes to propose furniture/items of alternate design/manufacture, such alternates must be submitted with the final RFP submission. Alternate furnishing must be equal or better quality in comparison to the base specification.

Please note that proposal deviating from the basis of design described will be rejected.

Qualifying requirements: The bidders should have experience in supplying/ dealing such type materials/ works.

Earnest Money/ Bid Security: Earnest money amounting to ₹ 27,000/-(Rupees twenty seven thousand) only to be deposited through online transfer to the account of the Corporation. The said earnest money will be 50% in case of ST supplier subject to submission of necessary ST Certificate from the Competent Authority.

MSME registered firms are exempted from submission earnest money subject to submission of MSME Certificate.

The rates quoted shall be FOR destination basis (FOR Tuirial H.E. Project, Mizoram) including manufacturing, packing, handling, forwarding, loading, unloading at site, installation, freight & cleanup of waste i.e (removal of non-recycling and recycling waste materials) all applicable Taxes and Duties including GST, Vat/Entry Tax, and any other charges complete in all respects.

Only one bid against one group from a party offering individually as well as under proprietorship/partnership firm shall be accepted.

Latest Income Tax Clearence Certificate / Exemption Certificate/ Copy of PAN Card, GST registration, Postal address, email are to be submitted along with the bid.

Bidders participating as Micro/Small Enterprise (MSE) shall submit a copy of the certificate issued by competent authority (District Industries Centre, Khadi & Village Industries Commission/ Board, Coir Board, NSCI, Director of Handicrafts & Handloom or any other body specified by Ministry of Micro, Small & Medium Enterprise).

SUBMISSION AND OPENING OF RFP/ BIDS:

Vendors shall prepare and submit their RFP/bids online in https://etenders.gov.in. Online bidding forms will be available in the above website. Detailed document can be downloaded from this website after vendor registration. In the online RFP/Bid submission, Bidders will submit their RFP/Bids using their digital signature.

Submission of online RFP/bid is mandatory.

Bidders may view the tender opening results in https://etenders.gov.in by marking their presence for online tender opening.
