North Eastern Electric Power Corporation Ltd., (NEEPCO), invites online bids from the shortlisted bidders under Single-Stage Two-Envelope bidding system for Preliminary Route Survey, Walkdown Survey and Final Route Alignment including Soil Resistivity of tower locations, preparation of Bill of Quantities for construction of 220 kV D/C Transmission Lines intended for evacuation of power from 186 MW Tato-I HEP & 280 MW Heo HEP and 400 kV D/C Transmission Lines intended for evacuation of power from 700 MW Tato-II HEP to the designated Pooling Substation at Kaying in Arunachal Pradesh.

The bids shall be submitted online through https://gem.gov.in.

#### A. BRIEF SCOPE OF WORK

The scope of work shall broadly include Preliminary / Walk over survey for finalization of the most economical and optimal route alignment for

- i) 220 kV D/C Transmission Line with Twin Moose Conductor from Pothead Yard of Tato-I Power House to Naying Pooling Station, with LILO of one circuit to Pothead Yard of Heo Power House, and
- ii) 400 kV D/C Transmission Line with Twin Moose Conductor from Pothead Yard of Tato-II Power House to Kaying Pooling Station.

The scope of work shall also include identification of tower locations, soil resistivity measurement of tower locations and framing of BoQ for the above transmission systems.

The scope of work is elaborated in detail in Vol-II of the Limited Tender Documents.

#### B. QUALIFYING REQUIREMENTS / ELIGIBLE BIDDERS

Only the Bidders shortlisted by NEEPCO for this particular tender are eligible to participate in this Tender. NILT is being sent to these Bidders by email separately to register in GeM portal (if not registered) and for bidding against this tender. 
