The North Eastern Electric Power Corporation Limited (NEEPCO Ltd.), a Public Sector Enterprise invites Online Single-Stage Two Envelope Bids having bid validity of 180 days through Domestic Competitive Bidding route from eligible bidders for the following work:

1. QUALIFYING REQUIREMENT (QR): Bidder must qualify the following criteria.

Sl. Minimum Technical Qualifying Criteria:

- 1.1. Experience of having successfully completed similar nature of work during last 7 years should be either of the following: -
- i) One similar work costing not less than the amount equal to 80% of the estimated cost.
- OR**
- ii) Two similar works each costing not less than the amount equal to 50% of the estimated cost
- OR**
- iii) Three similar works each costing not less than the amount equal to 40% of the estimated cost.



Similar works means Sweeping and Mopping/ Housekeeping Work etc.

1.2 Minimum Financial Qualifying Criteria:

1.2. **Minimum Average Annual Turnover (MAAT):** 30 % of the Estimated Cost.
i) Minimum Average Annual Turnover in the best 3 (three) financial years out of the last 5 (five) financial years, ending 31st March of the previous financial years, should not be less than **Rs. 90,330/-only.**

1.2. **The liquid Asset: Rs. 31,365/-** The bidder should have a liquid asset or/and evidence to availability of unutilized credit facilities of not less than **Rs.31,365 /-**
ii) .The Certificate of Banker regarding the availability of unutilized credit facilities (Fund based or Non-Fund based) shall not be dated earlier than 30 (thirty) days prior to the latest date for submission of bids.

1.3 Special Qualifying Criteria: The Firm should be registered at the State Tripura. For individual, proof of domicile / permanent resident of Tripura has to be submitted.

1.4 Other Important Documents to be submitted along with the Bid:

2. Bidder shall not be under declaration of ineligibility of corrupt & fraudulent practices as mentioned in the Instruction to Bidders.

4. **Relaxation to MSE & Startups:** Condition of Prior Work experience & Turnover may be relaxed subject to meeting quality & technical specifications. They are exempted from paying Tender Fee & EMD. For details of eligibility under this category refer Section - Instruction to Bidder and latest guidelines by Govt. of India.

6. Security Deposit / Performance Security:

The successful bidder shall for due performance of the Contract, deposit to NEEPCO **Security Deposit (SD) / Performance Security for an amount of @ 2% of the Estimated Value.**

7. **Estimated Cost:** Estimated cost is prepared on the basis of Minimum Wage Dtd. 12/10/2020 without GST and Contractor's Profit. GST shall be payable extra as per norms.
8. **Nos. of workers: 01 no. unskilled workers for 08 hours a day for 26 days per month.**
9. **Bidding Procedure:** Interested bidders, who fulfill the qualifying requirements as mentioned in the Bid Document, may download the bid document from



https://etenders.gov.in using their digital signature. The Bidder shall submit Bids under Single-Stage Two-Envelope bidding system through online as follows:
Techno-Commercial Bid (Cover-1): Shall contain Earnest Money Deposit (EMD), Bid Fee, documents in support of Qualifying Requirements and Techno-Commercial Bid. Bidder has to map documents against the following covers.

10. Since the estimate is based on minimum wage and EPF contribution only, the contractor shall quote his profit in percentage in the Price Schedule in excess of basic estimated cost. Quoting of Negative Percentage will be treated as disqualified from the bidding process. If there are more than one L1 Bidders (by quoting same percentage of profit), then the Bidder with **highest Minimum Annual Average Turnover (MAAT) as per clause of Financial Qualifying Criteria shall be considered eligible.**
11. **Workmen Compensation / Insurance:** Corporation shall not bear any responsibility towards any injury, Occupational illness, accident, death etc. The Contractor at his own interest to cover himself from losses arising out of such incidents shall insure. Cost of premium toward such insurance as applicable under statutory norms shall be reimbursed to the Contractor at actuals on submission of documentary evidence. No other incidental charges, Contractor's profit etc. shall be payable under this Clause.
12. **ESI:** Contractor's contribution towards ESI shall be reimbursed at actual on submission of documentary evidence.
13. Notwithstanding anything stated above the Corporation reserves the right to assess bidder's capacity and capability to perform the work, should the circumstances warrant such an assessment in overall interest of the owner.
14. The above requirements are minimum and the Corporation reserves the right to request for any additional information/certificates and also reserves the right to reject the proposal of any bidder if, in the opinion of Owner, the qualification data furnished by the bidder is incomplete or the bidder is found to be not qualified to satisfactorily perform the works.

Bids submitted without fulfilling the qualifying requirements shall be rejected.
17. Submission of bids shall not automatically construe qualification for evaluation. NEEPCO reserves the right to reject any or all bids, or to annul the bidding process and reject all the bids for any justified and genuine grounds, without thereby incurring any liability to the affected bidders, nor does it have any obligation to inform the bidders of the grounds for such action.


