1. E-Tendering / E-Procurement

- (i) Average annual turnover during the last 3(three) years ending 31st March of the previous financial year should be at least 30% of the estimated cost.
- (ii) Experience of having successful completion of similar nature of works during last 3(three) years ending last day of the previous month should be either of the following: -
 - (a) At least 3(three) similar completed works costing not less than the amount equal to 40% of the estimated cost in each work. Or,
 - (b) At least 2(two) similar completed works costing not less than the amount equal to 50% of the estimated cost in each work. Or,
 - (c) At least 1(One) similar completed works costing not less than the amount equal to 80% of the estimated cost in each work.

The above experience should be with any Government Department/ PSU/ Government Autonomous Body, Certificate in support of successful execution of work should be submitted. "Similar nature of works" means to related with construction of Fire Hydrant System work experience.

5. Credentials of the bidders:

Bidders are to submit the following particulars along with the detailed Bid Documents in support of the Qualifying Requirements.

- i) Documentary evidence of Registered Company or Partnership company or Proprietorship company.
- ii) Documentary evidence of EPF registration and payment of EPF contribution against employees regularly.

- iv) Documentary evidence of GST Registration certificate.
- v) Documentary evidence of registration with Department of Labour.
- vi) Copies of latest Income Tax Clearance Certificate and PAN card.
- vii) Copies of experience in this field.
- viii) Documentary evidence in respect of annual turnover.
- ix) The Bidder participating as Micro / Small Enterprises (MSE) shall submit valid document.
- x) The MSE's who have applied for registration or renewal of registration with authorized agencies / bodies, but have not obtained the valid certificate as on close date of tender, are not eligible for exemption /preference.
- xi) The MSE's registered agencies / bodies are exempted for payment of BID FEES and EARNEST MONEY DEPOSIT (EMD).
- vii) Vide MOF Letter No. F9/4/2020-PPD, GOI, Dated 12.11.2020: As per Rule 170 of General Finance Rules (GFRs) 2017, Micro and Small Enterprises (MSEs) and the firms registered with concerned Ministries /Departments are exempted from submission of Bid Security. Further, in lieu of Bid Security Ministries /Departments may ask bidders to "Bid Security Declaration" excepting that if they withdraw of modify their bids during period of validity etc., they will be suspended for the time specified in the tender documents. Similar provisions also exist in the Manual of Procurement of works 2019 and Manual for Procurement of Consultancy and other Services 2017.

6. Submission and opening of Bids:

- i) Bidders shall prepare and submit their bids online in https://etenders.gov.in. Online bidding forms will be available in the above website. Detailed Bid document can be downloaded from this website after vendor registration. In the online Bid submission, Bidders will submit their Bids using their digital signature.
- ii) Bidders may view the tender opening results in https://etenders.gov.in by marking their presence for online tender opening.

- 12. If the tender is submitted by a firm in partnership, it shall be signed by all the partners of the firm above their full names and current business address, or by a partner holding the Power of Attorney for the firm and signing the tender in which case certified copy of the partnership deed and current business of all the partners of the firm shall also accompany the tenders.
- 13. If the tender is submitted by a limited company or a limited corporation, it shall be signed by a duly authorized person holding the Power of Attorney for signing the tender in which case a certified copy of the Power of Attorney may be required to furnish with satisfactory evidence of its existence before the contract is awarded.
- **14.**On award of work the Contractor shall ensure that their workers are registered with the Assam Building & Other Construction Workers' Welfare Board as per the procedure mentioned in the Act and Rules.

15. REVERSE AUCTION:

- i) The Owner reserves the right to go for Reverse Auction process to finalize the tender or may finalize the tender without Reverse Auction. The decision to conduct Reverse Auction or not, will be conveyed to the techno-commercially qualified bidders after opening of Price Bid. The Business Rules and General Terms & Conditions for Reverse Auction is given in Section-IV of the Bid Document.
- ii) Bidders shall furnish the undertaking to participate in RA as per Form Declaration (Form-H) along with the techno-commercial bid in their letter head.
- iii) Bidders not confirming to participate in Reverse Auction if conducted by the Owner, then their original quoted price shall be treated as final quotation.
- iv) The techno-commercially qualified bidders who have confirmed acceptance to the Owner, but finally do not participate in Reverse Auction process, their original quoted price shall be considered as final.
- v) If a bidder does not want to quote any price below the starting/ ceiling price during Reverse Auction, their "Logged In" during Reverse Auction itself shall be considered as Participation. Their original quoted price shall be considered as final.
- vi) After opening the Price Bids and arriving at evaluated cost to the Owner after due commercial loading and other price impacts if any as per bid condition, the bidders whose Price Bids have been opened shall qualify for participating in the Reverse Auction event conducted as per Business Rules of RA.
- vii) It shall be Owner's discretion to use the Lowest Evaluated Cost already evaluated amongst the Price Bids or any other price as the Starting Price in Reverse Auction.
- viii) In case the Owner decides not to go for reverse auction procedure for the tender, the Price Bids already opened and evaluated shall be considered for finalising the tender.

- xi) If no bid is received during Reverse Auction within the specified time duration of the online Reverse Auction, the original quoted price of the bidders shall be processed to evaluate the lowest bid.
- xii) If the L1 bidder as per the original quoted prices does not participate in the Reverse Auction and the L-1 Bid received during RA happens to be the same as the L-1 price evaluated as per original quoted prices of the bidders, then the L-1 bid received during RA shall prevail and shall be considered for evaluation and award.
- xiii) The prices quoted in the e-reverse auction shall be the total lump sum prices for the scope of work as per tender inclusive of all applicable taxes & duties, levies etc. on his quoted prices as per Bid conditions.
