(NEEPCO), a Public Sector Enterprise under the Ministry of Power, Govt. of India invites sealed bids from the contractors of Meghalaya under the single stage, single envelop bidding system for "Collection of river discharge data under Wah Umiam Stage-III HEP (42.50MW x 2), EK Hills District, Meghalaya" as per the scope of works mentioned below:-

Non-transferable tender documents can be purchased from the office of the CGM (C)/ HoP, Wah Umiam Stage-III HEP, Mawsynram, Meghalaya, Pin- 793113 on any working day between 10.00 AM. to 3:00 PM with effect from 10/02/2023 against payment of Rs. 1000/- (Rupees one thousand) only plus 18 % GST (Rs. 1000 + Rs. 180 = Rs. 1180) as applicable in the form of non-refundable Demand Draft/ Banker's cheque in favour 'NEEPCO Ltd.' payable at Shillong, issued from any Nationalized Bank/Scheduled Bank.
- 2. The successful bidder has to submit the Contract Performance Guarantee (CPG) for an amount of Rs. 19,900.00 (Rupees nineteen thousand nine hundred) only before issuing of the Letter of Intent (LoI) or Work order. No interest will be paid on CPG in any form, to the bidders by the Corporation. The CPG shall be released by the Corporation within one month after expiry of contractual period.

- 3. The overall scope of work covered under this contract for Collection of river discharge data under Wah Umiam Stage-III HEP (42.50MW x 2), EK Hills District, Meghalaya.
- 4. The commencement of work and time of completion shall start from the date as mentioned in the Letter of Intent (LoI) or work order.
- 5. The contractors must have registration under any State/Central Government Department or any recognized Organization.
- 6. Copy of Income Tax/PAN Card and Professional Tax certificate clearance of current validity are to be submitted along with the application.
- 7. The intending bidders are requested to visit the work site to assess the requirement of the work, availability of the water, labours, accommodation to the work site etc. before submission of their tenders.
- 8. Bidders shall quote their rates in the supplied Bill of Quantities/Schedule of Rates enclosed with the tender papers.
- 9. Rates quoted by the bidders shall be inclusive of all applicable taxes and duties including GST. Rates have to be quoted in figures and words.
- 10. In case of delay in completing the work, ½% (half percent) of the total value of the work shall be recovered from the bill per week of delay subject to a maximum of 10% (ten percent) of the total value of the work.
- 11. The bidder shall submit the EPF Registration Number otherwise EPF deduction in respect of both the employees and employer's contribution will be made from their bills as per existing relevant norms. However this will not relieve the contractor from his responsibility.
- 12. Laws, Regulations and Acts pertaining to engagement of labours, Environment protection, Safety etc. shall be applicable.
- 13. Payment terms: Running Bills, on monthly basis, shall be released to the contractor on successful completion of the work in all respects. No escalation shall be payable against this work and no claim in this regard shall be entertained. No advance is payable under this contract.
- 14. The contractor shall have to supply all materials and labours etc. required for successful completion of the work in all respects.
- 15. The contractor shall adopt suitable quality assurance programme to the satisfaction of the Engineer-in-Charge.
- 16. In case the work has not been carried out as per the specification or to the satisfaction of NEEPCO or the contractor causes damage to the property of NEEPCO/Dorbar authority or any other damages not mentioned herein, NEEPCO shall have the right to recover any amount as suitable from the bill/Security Deposit/CPG/any other amount due to the contractor.
- 17. Each bidder shall submit 1 (one) either individually or as a partner in a Joint Venture.
- 18. Withdrawal of bids at any stage is not allowed. If due to unavoidable circumstances, the bidder wishes to withdraw his/her bid by written request, the bidder shall be disqualified for re-submission of bid.
- 19. The Engineer-in-Charge, may at his discretion, approve and authorize the contractor to sub-let, transfer or assign the whole or any part of the work. Nevertheless, any such approval or authorization shall not relieve the contractor from his responsibility.
- 20. From commencement to completion of the work as a whole, the contractor shall take full responsibility for the care thereof and for taking precaution to prevent loss or damage.
