NOTICE INVITING TENDER

The undersigned on behalf of "North Eastern Electric Power Corporation" (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) from experienced/reputed/preferably PLHPS registered contractors for execution of the following work with terms & conditions as mentioned.

1. **Name of the work:** " Repairing and renovation and construction of new septic tank and soak pit of A-Type Quarter No. 40 (Part-A&B) at PLHPS, NEEPCO colony, Yazali, Arunachal Pradesh."
2. **Scope of the Work:** - The work is to be executed as per Technical Specification attached in the tender document and as mentioned in the schedule of item enclosed in the tender document and as per instruction of the Engineer- In – Charge, **Sr. Manager, R&B (M), PLHPS.**
3. **Rate per unit basis:**
 - 3.1. Rate against each item shall be "FIRM" till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
 - 3.2. Bidders are to quote unit rates in figures and words for the items indicated in **Annexure-I** of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over-writing, changes and cuttings shall be initiated by the bidder.
 - 3.3. **Taxes, Duties & Levies:** Bidders shall quote their rates against respective item specification inclusive of all taxes including GST, Building Cess and all charges etc. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work.
4. **Estimated Amount:**
 - 4.1 **Rs. .6,99,741.00 (Rupees Six Lakh ninety nine thousand seven hundred forty one)** only for the work. Building Cess, GST and other taxes & charges as applicable will be deducted from work value.
5. **Payment Terms:** As per Paras, inter alia, 52,53,54 & 55 of Conditions of Contract attached.
 - 5.1 Payment will be released after satisfactory completion of work as certified by the Engineer-In-Charge. No part payment/advance payment will be entertained.
 - 5.2 90% Payment will be released on successful completion of the work. Balance 10% will be kept as Security deposit, which will be released after expiry of defect liability period for the work. In case of any defect in the work detected after the completion of the work within the defect liability period, shall be made good by the contractor at his own risk and cost, and no extra payment shall be made by the corporation.
6. **Paying Authority:** The paying authority shall be the **Head of Finance / Sr.Manager (F), PLHPS, Yazali (A.P).**
7. **Engineer-In-Charge:** The Engineer-In-Charge shall be **Sr. Manager, R&B (M), NEEPCO Ltd., PLHPS, 43 KM, Yazali, A.P.**
8. **Time of Completion:** The work shall be completed within **3 (Three) Months** from the date of issue of the Work Order or the date of handing over of site.
9. **Compensation for Delay:**

In case of delay in work of items within the stipulated period indicated in **clause no.8** above, compensation for delay at the rate of 0.5% (zero-point five percent) of the contract price per week or part thereof of delay shall be deducted subject to a maximum of 10% (Ten percent) of the contract sum.

10. **Defect Liability Period:** The works shall be subjected to a defect liability period of **1 (One) year** from the date of completion of work in all respect. The nature and extent of defects to be considered for the purpose of Defect Liability, shall be decided by the Head of Project / Engineer-In-Charge and decision of Head of Project / Engineer-In-Charge in this matter shall be final and binding. On expiry of defect liability period a Certificate in this regard shall be issued by the Engineer-in-charge. In case of non-compliance, the security deposit shall be forfeited as mentioned under clause No. 5.2
11. **Security Deposit:** 10 % (Ten percent) of the work value shall be retained as security deposit and the same shall be released after expiry of defect liability period or defect rectification work if any arises whichever is later.
12. **Earnest Money Deposit :**
Earnest Money of ~~Rs. 13,995.00~~ **(Rupees Thirteen thousand nine hundred ninety five) only** and **Rs. 6997.00 (Rupees Six thousand nine hundred ninety seven)** only for SC/ST Contractor shall be deposited through SBI Collect. Non-submission of EMD shall result in cancellation of the bid document. However, firms/ contractors registered in NEEPCO and UDYAM Registration are exempted from depositing earnest money along with tender in their respective class of registration.
13. Payment for online EMD through SBI Collect:

STEP-5	Select "North Eastern Electric Power Corporation" and click on "Submit"
STEP-6	Select "RHEP-PARTIES" in the drop-down menu
STEP-7	Fill the details a) Name b) In short details write EMD/ Tender Cost / NIT No. (As applicable) c) Choose Vendor --- Click on " Submit to continue"
STEP-8	This screen shall lead to payment gateway from where SBI and other banks, Debit/ Credit and wallet etc. may be chosen by vendor.
STEP-9	After completion of the process, a copy of the payment e-receipt may be taken and to be completed in the EMD / Tender cost attachment of the on-line bid
