The undersigned on behalf of "North Eastern Electric Power Corporation" (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) from experience/reputed/preferably PLHPS registered contractors for execution of the following work

- 1. Name of the work: Construction of wall on uphill side of IB approach road from junction of Quarter no. B(P)-3 to Union office, 43km, PLHPS, Ar. Pr.
- 2. Scope of the Work: The work is to be executed as per Technical Specification attached in the tender document and as mentioned in the schedule of items enclosed in the tender 3. Rate per unit basis:

- 3.1. Rate for the scope of work of respective item against specification shall be "FIRM" till completion of work irrespective of any quantity variation. No escalation of the rates will be
- 3.2. Bidders are to quote unit rates in figures and words for the items indicated in Annexure-I of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD deposited will be forfeited. Erasing, over writing, changes and cuttings shall be initialed by the bidders.
- 3.3. Taxes, Duties & Levies: Bidders shall quote their rates against respective item specification inclusive of all taxes and Duties including Forest Royalty, GST, Building Cess etc. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work. 4. Estimated Amount:
- 4.1 ₹ 27,22,093.00 (Rupees Twenty seven lakh twenty two thousand ninety three) only.
- 4.2 Building Cess, GST and other taxes & charges as applicable will be deducted from work 5. Payment Terms:

- 5.1 Payment will be released after satisfactory completion of work as certified by the Engineer-In-Charge as per clauses 52,53,54 and 55 of condition of contract. The Engineer-In-Charge shall be GM(Tech), R&B, PLHPS, NEEPCO Ltd. No part payment/advance payment will
- 5.2 90% Payment will be released on successful completion of the work.
- 6. Paying Authority: The paying authority shall be Head of Finance, PLHPS, Yazali (A.P).
- 7. Time of Completion: The work shall be completed within 10(Ten) Calendar Months from the date of issue of the Order or handing over of site.
- 8. Compensation for Delay: In case of delay in work of items within the stipulated period indicated in clause no.7 above, compensation for delay at the rate of 0.5% (zero-point five Tender Notice

- percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of 10% (Ten percent) of the contract sum.
- Defect Liability Period: The works shall be subjected to a defect liability period of 12(Twelve) month from the date of completion of work in all respect. The nature and extent of defects to be considered for the purpose of Defect Liability, shall be decided by the Head of Project/Engineer-In-Charge and decision of Head of Project/Engineer-In-Charge in this matter shall be final and binding. On expiry of defect liability period a Certificate in this regard shall be issued by the Engineer-in-charge. In case of noncompliance of clause, no 5.2
- 10. Security Deposit: 10% (Ten percent) of the work value shall be retained as security deposit and the same shall be released after expiry of defect liability period or defect rectification work if any arises whichever is later.
- 11. Earnest Money Deposit: Earnest Money ₹ 54,442.00 (Rupees Fifty Four Thousand Four Hundred Forty Two) only for General Contractors/Firm & ₹ 27,221.00 (Rupees Twenty Seven Thousand Two Hundred Twenty One) only for SC/ST contractor shall be submitted through SB collect. Non- submission of EMD shall result in cancellation of the bid. However, firms/contractors registered under NEEPCO and those having UDYAM (MSME) Registration shall be exempted from depositing earnest money while submitting bids. Steps for SB collect.
