# Notice Inviting Tender No – 31 /18-19 Dtd. 10/05/2018

The undersigned, on behalf of the Corporation hereby invites On-Line Bids under Single stage Two Envelope system through Domestic Competitive Bidding (DCB) route with a validity of 180 (One Hundred Eighty) Days from the Manufacturers/ Authorized Dealers for "Design, Engineering, Manufacturing, Supply, Delivery at site, Erection, Testing & Commissioning of 145 KV, 3150A, SF6 Circuit Breaker with Spring Operated Mechanism, Support Structure, terminal connector etc for 3 X 135 MW Dikrong Power House, Ranganadi H.E. Plant, NEEPCO Ltd, Arunachal Pradesh", as detailed herein under::

# 1. SCOPE OF WORK/SUPPLY:

The following works shall be under this contract.

- i. "Design, Engineering, Manufacturing, Supply, Delivery at site, Installation, Testing & Commissioning of 07(seven) sets of 145 KV, 3150A,SF6, Live tank Circuit Breaker with spring operated mechanism, suitable for three phase auto reclosing (mechanically gang operated), support structure, terminal connector for twin moose conductor, adaptor materials, earthing risers etc as per technical specifications enclosed under **Section-IV** "Technical Specification" and suitable for erection on existing foundation of circuit breaker for 3 X 135 MW Dikrong Power House, Ranganadi H.E. Plant, NEEPCO Ltd, Arunachal Pradesh".
- ii. The existing foundation, control & power cables, earthing materials of 145 KV Circuit Breakers shall be utilize for proposed breakers of this contract.
- iii. Support Structure of Circuit Breaker shall be suitably matched with the old foundation of existing circuit breaker. No additional foundation work shall be carried out for erection of the new circuit breaker. As such interested bidders are advised to visit site before submitting the bid.
- iv. The supplier shall be responsible for delivery of materials at site.
- v. Terminal connector for twin moose conductor, adaptor material shall match with existing other side of terminal.
- vi. Installation, Testing & commissioning of Circuit Breakers by authorized engineer/expert (who had required technical and academic qualifications) of the principal company.
- vii. All the tools & tackles, consumables, technical/skilled/unskilled manpower required for the job shall have to be arranged by the contractor.

The terms and conditions governing this tender are detailed in the subsequent sections of the Bid Document.

The details of Technical Specification/Particulars is given at Section-IV-"Technical specification", Schedule of Prices as Annexure – A, guaranteed technical particulars to be filled by bidders as Annexure-B, detailed drawings of existing Circuit Breaker as Annexure-C .

#### 2. COMPLETION TIME:

- (i) **Supply Part:** The total delivery period has been kept **06(six) Months** from the issue of detailed order which includes:-
  - (a) Submission of detailed drawings by the supplier for approval within one month from the date of issue of detailed order.
  - (b) The materials to be delivered within 05 (five) months from the date of approval of drawings from this end.
- (ii) **Installation, Commissioning & Testing:** Installation, Testing & Commissioning of each Circuit Breaker shall be completed **within 15** (**fifteen**) **days** from the date of handing over of site. Installation, Testing & Commissioning of Circuit Breaker shall be carried out feeder wise as per shutdown schedule granted by concerned authority.

#### 3. QUALIFYING REQUIREMENT:

- a) <u>TECHNICAL</u>: The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirements along with the Technical Bid document submitted/uploaded online.
  - (i) Trade License of the firm in case of authorized dealers showing his credential as a supplier / dealer of Electrical/Mechanical Materials.
  - (ii) Certificate of incorporation in case of a company, partnership deed in case of a partnership firm as the credential of the firm.
  - (iii) The bidders shall attach the following in support of his credentials:
    - (a) In case of authorized Dealer Valid Dealership certificate of the particular brand of material to be supplied as per stipulated technical specifications given by the OEM of the item.
    - (b) In case of Manufacturers License showing the firm to be manufacturer of the particular product.
  - (iv) The bidder shall have executed/supplied similar works/materials to any Govt. /PSUs organizations /Reputed agencies in the order as specified below:
    - (a) A single order of not less than ₹. 66.00 lacs executed by the firm in the last 05(five) years and the bidder shall submit the copy of the said supply order with completion certificate.

Or

(b) Two orders of not less than ₹. 41.00 lacs each executed by the firm in the last 05(five) years and the bidder shall submit the copies of the largest supply orders with completion certificate,

Or

(c) Three orders of not less than ₹. 33.00 lacs each executed by the firm in the last 05(five) years and the bidder shall submit the copies of the largest supply orders with completion certificate.

(v) Copy of provisional/ migrated GST ID, PAN number, Bank account details (along with IFSC code etc.) should be submitted/uploaded along with the Bid online. The documents submitted in support of the credential should be valid till the opening of the Bid as specified in the Tender.

# b) FINANCIAL:

The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.

- (i) Solvency certificate, not older than 6 months, by the firm from a nationalized / scheduled bank specifying the firm is financially sound to execute the contract amounting to ₹. 83.00 Lacs.
- (ii) Annual turnover by the firm in the best three financial years out of last five financial year ending March 2017 should not be less than ₹. 124.00 Lacs.
- c) Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 3.0 above shall be submitted/uploaded online along with the Techno-Commercial bid under Envelope I,. Bids submitted without fulfilling the qualifying requirements shall be rejected.
- d) The above requirements are minimum and the Corporation reserves the right to request for any additional information and also reserves the right to reject the proposal of any bidder if, in the opinion of owner, the qualification data furnished by the bidder is incomplete or the bidder is found to be not qualified to perform the work satisfactorily.
- e) Notwithstanding anything stated above, the Corporation reserves the right to assess bidders' capability and capacity to supply the item, should the circumstances warrant such an assessment, in the overall interest of the Owner.
- f) Each bidder shall submit only 1 (one) bid. A bidder who submits or participates in more than 1 (one) bid will be disqualified.
- g) If an agent submits bid on behalf of one manufacturer/ dealer, the same agent shall not submit a bid on behalf of another manufacturer/dealer in the same tender.

# 4. E-TENDERING / E-PROCUREMET :

This tender is being processed through e-tendering/e-procurement system. The bidding documents are to be downloaded, filled in bids are to be submitted/ uploaded through e-tendering system of NEEPCO Ltd. at https://neepco.abcprocure.com.

# 5. PARTICIPATING IN THE BID:

#### 5.1 **Portal Registration**:

The bidders intending to participate in the e-tendering and download the detailed bid document have to register themselves in the portal https://neepco.abcprocure.com. Relevant information about the bidder required during the registration is available in the portal.

5.2 Vendor registration fee: The fees for Vendor Registration in the portal is ₹. 3000.00(Indian Rupees three thousand) only per year (Non-Refundable). Bidders who are already registered in the system shall ensure to keep their registration valid till completion of the entire bidding process.

Bidders shall make payment of vendor registration fee of ₹. 3000.00 (Indian Rupees Three Thousand only) online through "SB Collect" detail procedure/steps is given in the section Instruction to Bidders at Sl. No. 8.1.

#### 6. PROCEDURE FOR PAYMENT OF BID FEES & EMD:

### 6.1 Bid Fees

- a) Bidder shall make payment of non refundable Bid fees of amount ₹. 1180/- (Rupees One Thousand One Hundred Eighty) only inclusive of 18% GST online through "SB Collect" details of which is given in the section Instruction to Bidders at Sl. No. 8.2. A copy of payment receipt to be uploaded in the e-tendering site falling which the bid shall not be considered. Further Documentary evidence of the Bid Fees paid shall accompany the Technical Bid. The invoice against the Bid Fee shall be submitted to the bidder after opening of the e-tender.
- b) Bids received online without Cost of Bid Documents shall be rejected

# 6.2 EMD

Bidder shall make payment of refundable EMD of amount ₹. 1,65,200/- (Rupees One Lac Sixty Five Thousand Two Hundred) only online through "SB Collect" details of which is given in the section Instruction to Bidder at Sl. No. 8.2. A copy of payment e-receipt to be uploaded in the e-tendering site falling which the bid shall not be considered. The EMD can also be submitted in the form of Bank Guarantee from a Nationalised Bank with a validity of 180 days from the date of opening of tender. The Bank Guarantee format in lieu of EMD is enclosed in the Section-Forms of this bid document. A copy of BG to be uploaded in the e-tendering site falling which the bid shall not be considered. Bids received online without EMD shall be rejected.

The details for submission of Bank Guarantee in lieu of EMD is given in section-Instruction to Bidder at Sl. No. 7.3

- 6.3 Exemptions for MSME's shall be applicable under the Govt. of India norms under PPC guidelines.
- 6.4 Also the Price preference as applicable to MSME's as per Govt. of India Norms, during evaluation of the Bid shall be applicable.
