The scope of work under this tender covers the following:

**Construction of Paver Block Apron in the Office Complex of Divisional Forest Officer (DFO), Along Forest Division, Aalo, Arunachal Pradesh**, as detailed at Part-4 (Technical Specifications) and Part-6 (Bill of Quantities) of Bid Document.

#### 3. Bidding Procedure:

The Bidder shall submit Bids under Single-Stage Single-Envelope bidding system through online. The Single Envelope shall contain all the documents such as Tender Forms & Data Sheets and Price Bid.

#### 4. Time of Completion:

The scheduled Time for Completion of Works shall be 45 (Forty-Five) days reckoned from the date of issue of Letter of Acceptance by the Employer.

The bidders shall submit a construction programme considering Equipment planning, and mobilization of other resources so as to complete the Works within the stipulated Time for Completion.

#### 5. Earnest Money Deposit/ Bid Security:

Earnest Money Deposit shall be Rs. 40,000.00 (Rupees Forty Thousand) only.

For bonafide Arunachal Pradesh Schedule Tribe (APST), EMD shall be Rs. 20,000.00 (Rupees Twenty Thousand) only. The APST bidders shall submit Schedule Tribe Certificate issued by the competent
