1. Brief Scope of Work: Design, Manufacture, Testing at Manufacturer's works before despatch, Insurance, Supply, Delivery at site, Erection, Testing and Commissioning of 1 No. Cummins Make 750 KVA Diesel Generator Set (DG) with all accessories for emergency power requirement.

- 3. Condition for Micro & Small Enterprises (MSEs)

- 3.2 The MSEs owned by Scheduled Caste (SC) & Scheduled Tribe (ST) entrepreneurs must submit the SC/ST certificate issued by District Authority in addition to certificate of registration with any one of the agencies mentioned above. The bidder shall furnish necessary documentary evidence to ascertain that the MSE is owned by SC/ST. MSE owned by SC/ST is defined as:

- a) In case of proprietary MSE, proprietor(s) shall be SC /ST.
- b) In case of partnership MSE, the SC/ST partners shall be holding at least 51% shares in the enterprise.
- c) In case of Private Limited Companies, at least 51% share shall be held by SC/ST promoters.
- 3.3 The registration certificate submitted by MSEs issued from any one of the above agencies must be valid as on close date of the tender. The successful bidder should ensure that the same is valid till the end of the contract period.
- 3.4 The MSEs who have applied for registration or renewal of registration with any of the above agencies/bodies, but have not obtained the valid certificate as on close date of the tender, are not eligible for exemption/preference.
- 3.5 The MSEs registered with above mentioned agencies/bodies are exempted from payment of EARNEST MONEY DEPOSIT (EMD).

### 4. BID GUARANTEE/ EARNEST MONEY DEPOSIT:

A bid guarantee equivalent to INR 2,10,000 (Indian Rupees Two lakh Ten thousand) only shall accompany each bid, details for submission of EMD is provided in Bid Document.
