**NOTICE INVITING BIDS**

1. North Eastern Electric Power Corporation Limited, a leading Miniratna Category-I Public Sector Enterprise under the Ministry of Power, Government of India, invites online tender at e-procurement portal <https://etenders.gov.in> under Single-Stage Two-Envelope bidding process through Domestic Competitive Bidding (DCB) route from the IRDA registered Non-life Insurers for **undertaking Industrial All Risk (IAR) Insurance Policy for the Assets of Kameng Hydro Electric Plant (600 MW), West Kameng District, Arunachal Pradesh, for a period of 1(one) year w.e.f. 00:00:00 Hours of 17.06.2021**, with a validity of 90 (ninety) days from the date of opening of Techno-Commercial bids.

2. **Bidding Procedure**

The Bidder shall submit Bids under Single-Stage Two-Envelope bidding system through online as follows:

**Techno-Commercial Bid (Envelope No. 1):** Shall contain all the Bidding Forms, Form F-1 to Form F-10 as stipulated at Section-VII (Part-A) of bid document in support of Techno-Commercial Bid.

**Price Bid (Envelope No. 2):** Shall contain Price Bid Forms, Form-A: Price Schedule and Form-B: Break up of Premium as stipulated at Section-VII (Part-B) of bid document. Price Bids of only those Bidders who qualify in Techno-Commercial evaluation shall be opened.

3. **Registration for Participation in Bids**

- 3.1 Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: <https://etenders.gov.in/eprocure/app>) by clicking on the link **"Online bidder Enrolment" on the CPP Portal which is free of charge.**
- 3.2 As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3.3 Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 3.4 Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (**Class III Certificates with signing key usage**) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 3.5 Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 3.6 Bidder can then log in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.



Bidders are requested to get themselves enrolled on the e-Procurement Portal ([URL: https://etenders.gov.in/eprocure/app](https://etenders.gov.in/eprocure/app)) well in advance and no extra time will be considered for submission of bids for the delay in enrolling on the e-Procurement portal.

#### 4. Submission and Opening of Bids

- 4.1 Bidders shall prepare and submit their bids online in e-Procurement portal <https://etenders.gov.in>. Online bidding forms will be available in the above website. Submission of online bids is mandatory for consideration of the bids by NEEPCO.
- 4.2 The bidder shall refer to the Instruction for online bid submission given at Section-III, Instruction to Bidders of the bid document.
- 4.3 The bids shall be opened at the date & time mentioned at Clause 6 below.

#### 5. E-Reverse Auction:

The tender shall be finalized through "Tender Cum Auction" i.e. through the tender followed by e-Reverse Auction (e-RA). After opening the Financial Bids, Reverse Auction shall be conducted amongst the Techno-Commercially qualified bidders, excluding the Highest (H1) bidder. The date and timing for the Reverse Auction shall be conveyed to the Techno-Commercially qualified bidders. There will be no participation fees for Reverse Auction. The Instruction for Bidders for e-RA is given at Section-VI of the Bid Document.

#### 6. Important Dates & Bid Validity:

- (a) Date of commencement of downloading of bid document from the portal <https://etenders.gov.in>: **w.e.f. 11:00 Hours on 13.04.2021.**
- (b) Last date of receipt of bid queries: **14:00 Hours on 23.04.2021.**  
**Any queries received after expiry of the last date and time of receipt of bid queries shall not be entertained by NEEPCO.**
- (c) Date of Pre-Bid Meeting (through Video Conferencing): **Shall be held on 26.04.2021 at 11:00 Hours.**  
**Pre-Bid Meeting shall be held with the prospective bidders accompanied by their concerned Re-insurer through Video Conferencing on the appointed date. Accordingly, bidders are advised to take necessary action in advance for participation in the pre-bid meeting along with their Re-Insurers for providing clarification to Re-insurer's queries, if any.**  
**Bidders are advised to submit the name, e-mail ID and mobile numbers of their authorised representatives and representative of proposed Re-Insurers who shall participate in the pre-Bid meeting latest by 23-04-2021 indicating the name of the Re-Insurer.**
- (d) End date & time for downloading of bid document: **14:00 Hours on 03.05.2021.**
- (e) Last date & time for receipt of **Online bids**: **Upto 14:00 Hours on 03.05.2021.**
- (f) Last date & time for receipt of **Offline bids**: Within 7(seven) days from the date of opening of Techno-Commercial Bids.
- (g) Date & time for opening of Techno-Commercial bids online: **At 14:00 Hours onwards on 04.05.2021.**
- (h) Date & time for opening of Price bids online: Date & time for opening of Price Bids online along with the list of Techno-Commercially qualified bidders shall be published in the tender portal.
- (i) **Bid validity**: 90 (Ninety) days from the date of opening of techno-commercial Bids.

In the event the date at serial (g) above is declared as a closed holiday for NEEPCO then opening of Techno-Commercial Bids will stand postponed to the following working day at the appointed times.
