- 1. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. - 1. The OEM should not be Blacklisted by any Central/State/PSU or any Government organization in la st 5 years. Self Declaration in this respect must be submitted.
- 2. The Wi-fi Controller, Next Generation Firewall (NGFW) and Access Points (APs) offered must be from the same OEM.
