North Eastern Electric Power Corporation Limited (NEEPCO), a public Sector Enterprise under the Ministry of Power, Government of India invites Single-Stage Two Envelope Bids through online bidding system from eligible & experienced bidders for execution of "Cable Networking in NEEPCO Bhawan, Guwahati and associated rectification works of Electrical Control Room, Panel & Cabling Network, NEEPCO Guwahati." with 180 (One hundred Eighty) days validity from the date of opening of the Bid.

DETAILS OF THE NIT:

1. **SCOPE OF WORK:** The scope of work covered under this tender for -
 1. Demolishing of concrete and providing cement concrete work as per necessary.
 2. Demolishing of damaged cables and keeping the same properly as directed by the Department.
 3. Fabrication and erection of cable trays with necessary components for laying of cable.
 4. Laying of power cable properly along with switch gear MCCBs, MCBs and Lug etc.
 5. PCC work for post.
 6. Supplying of MS cable tray.
 7. Supplying of MS cable trays tee.
 8. Laying of cables.
 9. Replace 11 outdated switchgears (63A and 125A) with MCCBs and MCBs.
 10. Replace 120 lugs.
 11. Perform panel modifications with necessary fabrication.
 12. Re-lay all cables properly with markings to ensure organized and hazard-free distribution inside the control panel room.

The detailed Scope of Works shall be indicated in the relevant Technical Specifications mentioned in the Bill of Quantities.

2. QUALIFYING REQUIREMENT OF BIDDERS:

The bidder shall provide satisfactory evidence concerning the following:

- (a) At least 3(three) similar completed works costing not less than the amount equal to 40% of the estimated cost in each work. Or,
- (b) At least 2(two) similar completed works costing not less than the amount equal to 50% of the estimated cost in each work. Or,
- (c) At least 1 (One) similar completed works costing not less than the amount equal to 80% of the estimated cost in each work.

The above experience should be with any Government Department/PSU/Government Autonomous Body, Certificate in support of successful execution of work should be submitted. "Similar nature of works in electrical field" shall mean switchgears (63A and 125A) with MCCBs and MCBs, Pole MCCB, Aluminum Lug for 35 sq. mm cable etc.

3. PORTAL REGISTRATION:

4. CREDENTIALS OF BIDDERS:

Bidders are to submit the following particulars along with the detailed Bid Documents in support of the Qualifying Requirements.

- Documentary evidence of Registered Entity in India /Company or Partnership company.
- Documentary evidence of EPF registration and payment of EPF contribution against employees regularly.
- Documentary evidence of Registration under ESI act, 1948.
- Documentary evidence of GST Registration certificate along with GST Return (GSTR 1/GSTR 3B/GSTR 9 etc.).
- Copies of latest Income Tax Clearance Certificate and PAN card.
- Copies of experience in this field.
- Documentary evidence in respect of annual turnover for last 3(three) years.
- The Bidder participating as Micro / Small Enterprises (MSE) shall submit valid document.
- The MSE's who have applied for registration or renewal of registration with authorized agencies / bodies, but have not obtained the valid certificate as on close date of tender, are not eligible for exemption /preference.
- The MSE's registered agencies / bodies are exempted for payment of BID FEES and EARNEST MONEY DEPOSIT (EMD).
- Security Deposit:** 10% (Ten percent) of the work value shall be retained as security deposit and the same shall be released after expiry of defect liability period or completion of defect rectification work if any arises or whichever is later.

Any lack of knowledge to this effect on the part of the Bidder shall not entitle the contractor for any claim whatsoever and shall not be considered a cause of delay. The Tenderer are therefore once again advised to inspect the entire working front and make proper planning before submission of Tender.

8. The tender should be submitted in the prescribed form and the same should be signed properly as laid down here under:

9. If the tender is submitted by any individual, it shall be signed by the proprietor above his full name and full name of his firm with its current business address.

10. If the tender is submitted by a firm in partnership, it shall be signed by all the partners of the firm above their full names and current business address, or by a partner holding the Power of Attorney for the firm and signing the tender in which case certified copy of the partnership deed and current business of all the partners of the firm shall also accompany the tenders.

11. If the tender is submitted by a limited company or a limited corporation, it shall be signed by a duly authorized person holding the Power of Attorney for signing the tender in which case a certified copy of the Power of Attorney may be required to furnish with satisfactory evidence of its existence before the contract is awarded.

12. On award of work, the Contractor shall ensure that their workers are registered with the Assam Building & Other Construction Workers' Welfare Board as per the procedure mentioned in the Act and Rules.
