North Eastern Electric Power Corporation Limited, a leading Miniratna Category-I Public Sector Enterprise under the Ministry of Power, Government of India, invites online electronic bids from prospective experienced bidders under Single-Stage Two Envelope bids through Domestic Competitive Bidding (DCB) for Permanent Internal Electrification of Mitshubishi Camp,Block no-3 of AGBP.
2. **BIDDING PROCEDURE:**
The Bidder shall submit Bids under Single-Stage Two-Envelope bidding system through online as follows:

Techno-Commercial Bid (Envelope No. 1): Shall contain Earnest Money Deposit (EMD), documents in support of Qualifying Requirements and Techno-Commercial Bid.
Price Bid (Envelope No. 2): Shall contain Price Bid. Price Bids of only those Bidders who qualify in Techno-Commercial evaluation shall be opened.
3. **TIME OF COMPLETION:**
The time allowed for completion of the supply in all respect shall be 30 (Thirty)Days
4. **EARNEST MONEY DEPOSIT:** Earnest Money Deposit shall be Rs 13000.00 (Rupees thirteen thousand) only .The procedure for depositing the EMD is mentioned in clause 7.4. A scanned copy of proof of depositing the EMD is to be uploaded online. Tenders not accompanied with requisite EMD or Tenders accompanied with EMD of inadequate value will be rejected .The bidders registered as Micro/ Small Enterprises are exempted from paying applicable Earnest Money Deposit (EMD).
5. **SCOPE:** Permanent Internal Electrification of Mitshubishi Camp,Block no-3 of AGBP as per Ann-I
6. **QUALIFYING REQUIREMENTS:**
Only the reputed firm can bid for this tender. The bidders should have experience of executing similar types of work in any industrial organization/GovtDeptt..both state and central/Govt. of India undertaking anywhere in India in last three years. Bidder should have valid electrical license, valid electrical supervisor license, P.F. Registration , PAN card and GST registration certificate.

19. **Court of Competent Jurisdiction:** Any legal action taken or proceeding initiated or any of the terms of the agreement shall be only in the jurisdiction of local court of this Power Station area in Dibrugarh, Assam.
20. **Force majeure:** Force majeure is herein defined as any cause which is beyond the control of supplier or purchaser as the case may be, which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affects the performance of the contract. This includes but not limited to wars, insurrection, civil disobediences, strikes, riots, epidemics, earthquakes, storms, floods, explosions or fire not caused by contractors negligence, lightning acts of God or the Public enemy which is of such a nature. Such occurrence will be notified by the either party within 15 days from the date of occurrence. The purchaser or the supplier shall not be liable for delays in performing his obligations resulting from any force majeure cause as referred above. The date of completion will, subject to hereinafter provided, be extended by a reasonable time even though such cause may occur after supplier's performance of obligation has been delayed due to other causes.
21. NEEPCO reserves the right to reject any or all bids, or to annul the bidding process and reject all the bids for any justified and genuine grounds without thereby incurring any liability to the affected bidders, nor does it have any obligation to inform the bidders of the ground for the action of NEEPCO.
22. **REVERSE AUCTION:**
 - i) The bidders whose price bids have been opened may require to participate in the Reverse Auction event conducted as per Business Rules and Conditions for Reverse Auction which is incorporated in the bid document is attached at **Annexure-II** of this Part. The Purchaser reserves the right to go for Reverse Auction process to finalize the

tender or may finalize the tender without Reverse Auction, if required. However, the decision to conduct Reverse Auction or not will be conveyed to the techno-commercially qualified bidders after opening of Price Bid. In case the Purchaser decides not to go for the reverse auction procedure for the tender, the price bids already opened and evaluated shall be considered for finalizing the award.

- ii) Bidders shall furnish the Declaration for Reverse Auction (**Annexure-III**) along with the techno-commercial bid in their letter head.
- iii) Bidders not confirming to participate in Reverse Auction if conducted by the Purchaser, then their original quoted price shall be considered as final.
- iv) The bids of the techno-commercially qualified bidders who have confirmed acceptance to the Purchaser on reverse auction, but do not participate in Reverse Auction, then their original quoted price shall be considered as final.
- v) If a bidder does not want to quote any price below the opening/starting/ base price during Reverse Auction, their “Logged In” during Reverse Auction itself shall be considered as Participation. Then their original quoted price shall be considered as final.
- vi) The following procedure shall be adopted for the Reverse Auction.
 - a) It shall be Purchaser’s discretion to use the Lowest Evaluated Cost already evaluated amongst the Price Bids or any other price as the opening /starting/ base Price in Reverse Auction.

If the L1 Price is taken as opening /starting/ base price for conducting the Reverse Auction, then for the purpose of convenience, the L1 price shall be corrected to nearest lower multiple of 100.
 - b) Decrement value shall be 0.5% of the starting/ base price, corrected to nearest multiple of 100.
 - c) The minimum Price quoted by a bidder while concluding the Reverse Auction shall be considered as the lowest bid. The bidder shall be called the lowest bidder / Auction winner and the price quoted by the Auction Winner shall be called lowest price.
 - d) The percentage decrease of the lowest price quoted by the Auction Winner with respect to the price quoted by the same bidder in his original Price Bid shall be effected on each rates of items quoted by the Auction Winner in the BOQ of his original Price Bid.
- vii) After completion of reverse auction, the lowest bidder has to fax/e-mail the duly signed filled in prescribed format **Annexure-IV**: Price Confirmation and **Annexure-V**: Price Break-up (If required) under this Part confirming the price quoted within 24 hours of auction without fail.
- viii) If no bid is received during reverse auction within the specified time duration of the online reverse auction, the original price quoted by the Techno Commercially qualified bidders in Price Bids shall be evaluated for award to the lowest bidder.

- ix) If the L1 bidder as per the original Price Bid does not participate in the e-reverse auction, then the L1 price received during reverse auction shall be considered for evaluation and award.

1. For the proposed reverse auction, technically and commercially acceptable bidders only shall be eligible to participate.
2. NEEPCO will engage the services of M/s. e-Procurement Technologies Ltd, Ahmedabad, (ETL), the service provider who will provide all necessary training and assistance before commencement of on line bidding on Internet. The bidders may contact the service provider for necessary assistance and training.
3. Business rules like event date, time, start price, bid decrement, extensions, etc. also will be communicated through service provider for compliance.
4. Vendors have to fax/e-mail the process compliance form in the prescribed format (**Annexure-2**) before start of Reverse auction. Without this the vendor will not be eligible to participate in the event.
5. Reverse auction will be conducted on schedule date & time.
6. At the end of reverse auction event, the lowest bidder value will be known on the network.
7. The lowest bidder has to fax/e-mail the duly signed filled-in prescribed format (**Annexure-3**) as provided to NEEPCO through service provider within 24 hours of auction without fail.
8. Any variation between the on-line bid value and signed document will be considered as sabotaging the tender process and will invite disqualification of vender to conduct business with NEEPCO as per prevailing procedure. In such case, the on-line bid value shall be considered for evaluation and award.
9. In case NEEPCO decides not to go for Reverse auction procedure for this tender enquiry, the award shall be decided on the basis of price bids of Techno-Commercially qualified bidders, in terms of Bid document.
10. **The reverse auction will be treated as closed only when the bidding process gets closed in all respects for the item listed in the tender.**

Business Rule for finalization of the procurement

NEEPCO may finalize the procurement against this Tender through reverse auction mode. NEEPCO has made arrangement with M/s. e-Procurement Technologies Ltd, Ahmedabad, (ETL) who shall be NEEPCO's authorized service provider for the same. Please go through the guidelines given below and submit your acceptance to the same along with your Techno-Commercial Bid through a Declaration (Form-H, Vol-5 of Tender Forms & Data Sheet).

1. Computerized Reverse auction shall be conducted by NEEPCO, on pre-specified date, while the vendors shall be quoting from their own offices/ place of their choice. Internet connectivity and other paraphernalia requirements shall have to be ensured by vendors themselves. In the event of failure of their Internet connectivity, (due to any reason whatsoever it may be) it is the bidders responsibility / decision to send fax communication, immediately to E-Procurement Technologies Ltd.(ETL) furnishing the price, the bidder wants to bid online, with a request to ETL to upload the faxed price on line so that the service provider will up load that price on line on behalf of the Bidder. It shall be noted clearly that the concerned bidder communicating this price to service provider has to solely ensure that the fax message is received by ETL in a readable / legible form and also the Bidder should simultaneously check up with ETL over phone about the clear receipt of the price faxed. 9. **Procedure of Reverse Auctioning**

a) **Online English Reverse (no ties) Auction {Reverse Auction}:** NEEPCO will declare its **Opening Price (OP)**, which shall be visible to the all vendors during the start of the reverse Auction. You will be required to start bidding after announcement of Opening Price and decrement amount. Also, please note that the start price of an item in online reverse auction is open to all the participating bidders. Any bidder can start bidding, in the online reverse auction, from the start price itself. Also, please note that the first online bid that comes in the system during the online reverse auction can be equal to the auction's start price, or lesser than the auction's start price by one decrement, or lesser than the auction's start price by multiples of decrement. The second online bid and onwards will have to be lesser than the last Accepted bid rate by one decrement value, or lesser than the last Accepted Rate by multiples of the decrement value.

b) The bid decrement amount shall be specified by NEEPCO.

c) English Reverse (no ties) shall be for a **period of 1 Hour**. If a bidder places a Bid in the last 5 minutes of Closing of the Auction, the auction shall get extended automatically for another 5 minutes. **In case, there is no Bid in the last 5 minutes of closing of Auction, the Auction shall get closed automatically without any extension.**

d) Auto Bid : (If Applicable)

i) The Auto Bid feature allows Bidders to place an automated bid against other Bidders in an auction and bid without having to enter a new amount each time a competing Bidder submits a new offer.

ii) Bidders are supposed to quote their best lowest price in confirmation to the decrement value. - 11. During English Reverse (no ties), if no bid is received within the specified time, NEEPCO, at its discretion, may decide to revise Opening price / scrap the reverse auction process / proceed and the award shall be decided based on Price Bids of the Techno-Commercially qualified bidders.
- 12. Bidders' bid will be taken as an offer to supply/ provide service/ execute work. Bids once made by bidder, cannot be cancelled / withdrawn and bidder shall be bound to supply/ provide service/ execute work (as per scope mentioned in The Bid document) at bidder's final bid price. **Should any bidder back out and not supply/ provide service/ execute work as per the rates quoted, NEEPCO shall take action as appropriate.**

16. NEEPCO shall not have any liability to bidders for any interruption or delay in access to the site irrespective of the cause.
17. Other terms and conditions shall be as per your techno-commercial offers and other correspondences /final confirmation against the NIB.
18. Vendors are required to submit their acceptance to the terms / conditions / modality given above before participating in the reverse auction as per **Annexure-2** (Process Compliance Form).
19. **LOG IN NAME & PASSWORD:**
Each Bidder is assigned a Unique User Name & Password by ETL. The Bidders are requested to change the Password after the receipt of initial Password from ETL. All bids made from the Login ID given to the bidder will be deemed to have been made by the bidder.
20. **LOWEST BID OF A BIDDER:**
In case the bidder submits more than one bid, the lowest bid will be considered as the bidder's final offer to execute the work.
21. **AUCTION TYPE:**
English Reverse Auction No Ties.
22. **DURATION OF AUCTION:**
The auction will be of 60 Mins duration. In case there is any acceptable bid quoted by any bidder within 5 minutes of closing of the auction, the auction will be extended by another 5 minutes. Such extension will be allowed to continue till no quote is placed within 5 minutes of the last quote.
