1. Scope of Work: The scope of work covered under this tender for "Essential repairing and painting of common areas at 2nd and 3rd Floors of NEEPCO Bhawan and some repairing works at NEEPCO Guest House, Guwahati and Providing aluminium doors and windows at Technical section of O/o ED(P)-Hydro, ground floor, NEEPCO Bhawan, Guwahati.)" including supplying of all materials and labours required for the work. The detailed Scope of Works has been indicated in the relevant Technical Specification mentioned in the Bill of Quantities.

2. QUALIFYING REQUIREMENT OF BIDDERS:

The bidder shall provide satisfactory evidence concerning the following:

Technical: Prospective bidders have to submit the following particulars with similar nature of work experience are: -

- (i) Average annual turnover during the last 3(three) years ending 31st March of the previous financial year should be at least 30% of the estimated cost.
- (ii) Experience of having successful completion of similar nature of works during last 3(Three) years ending last day of the previous month should be either of the following: -
 - (a) At least 3(three) similar completed works costing not less than the amount equal to 40% of the estimated cost in each work. Or,
 - (b) At least 2(two) similar completed works costing not less than the amount equal to 50% of the estimated cost in each work. Or,

(c) At least 1(One) similar completed works costing not less than the amount equal to 80% of the estimated cost in each work.

The above experience should be with any Government Department/ PSU/ Government Autonomous Body, Certificate in support of successful execution of work should be submitted. "Similar nature of works" means to related with construction of Building / Repairing of Building works experience.

3. Credentials of the bidders:

Bidders are to submit the following particulars along with the detailed Bid Documents in support of the Qualifying Requirements.

- i) Documentary evidence of Registered Company or Partnership company or Proprietorship company.
- ii) Documentary evidence of EPF registration and payment of EPF contribution against employees regularly.
- iii) Documentary evidence of Registration under ESI act, 1948.
- iv) Documentary evidence of GST Registration certificate.
- v) Documentary evidence of registration with Department of Labour.
- vi) Copies of latest Income Tax Clearance Certificate and PAN card.
- vii) Copies of experience in this field.
- viii) Documentary evidence in respect of annual turnover.
- ix) The Bidder participating as Micro / Small Enterprises (MSE) shall submit valid document.
- x) The MSE's who have applied for registration or renewal of registration with authorized agencies / bodies, but have not obtained the valid certificate as on close date of tender, are not eligible for exemption /preference.
- xi) The MSE's registered agencies / bodies are exempted for payment of BID FEES and EARNEST MONEY DEPOSIT (EMD).
- xii) Vide MOF Letter No. F9/4/2020-PPD, GOI, Dated 12.11.2020: As per Rule 170 of General Finance Rules (GFRs) 2017, Micro and Small Enterprises (MSEs) and the firms registered with concerned Ministries /Departments are exempted from submission of Bid Security. Further, if the bidder withdraws or modify their bids during period of validity etc., they will be suspended for the time specified in the tender documents. Similar provisions also exist in the Manual of Procurement of works 2019 and Manual for Procurement of Consultancy and other Services 2017.
