- 1. SCOPE OF THE SUPPLY: -This includes the Supply of a hired vehicle TATA Truck-LPT 1616, as per the Technical Specification detailed in the Bid document along with providing of a driver and handyman, for the operation of the vehicle to be executed as per the Terms and Conditions of the NIT.
 - 1.1 The Vehicle shall be utilized on round the clock basis for transportation of materials of Panyor Lower Hydro Power Station as per requirement and as directed by the Plant Authority or his authorized representative.
 - 1.2 The Vehicle shall be placed under the General Manager (Tech), PH&SY(O&M), PLHPS, Hoj, and shall be engaged against the duties specified by him.
 - 1.3 The utilization of the vehicle shall be carried out within the Panyor Lower Hydro Power Station area and also other Project / Sites / Officials of NEEPCO as directed by the Plant authority.

1.4 As per requirement, the vehicle may also be deputed to carry out other duties, not pertaining to this Plant as directed by the Dy. General Manager (HR) or his authorised representatives.

2. DOCUMENTS AGAINST QUALIFYING REQUIREMENT:

- 2.1 <u>Technical</u>: The bidders shall fulfil the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted. The documents submitted in support of the credential should be valid till the opening of the Bid as specified in the Tender.
 - (i) The bidder should be a registered contractor of PLHPS and a copy of the valid registration certificate as on the date of issue of NIT shall be submitted.
 - (ii) A copy of the Trade License of the firm valid on the date of issue of NIT shall be submitted as the credential of the firm.
 - (iii) Copies of the GST registration & GST Return, EPF registration & PAN number.
 - (iv) Details of the Bank Account No (along with IFSC code) number along with cancelled cheque should be submitted along with the Bid.
 - (v) An undertaking to the effect that the Bidder has not been blacklisted by any of the Departments/ Organizations of the Government of India/ State Government.
 - (vi) The bidder may also provide details of vehicles currently engaged by the bidder in this Plant or in other organisations, if already engaged by him.
- 2.2 Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 2.1 shall be submitted along with the containing Techno-Commercial bid under Envelope I, along with EMD. Bids submitted without fulfilling the qualifying requirements shall be rejected
- 3. The above requirements are minimum and the Corporation reserves the right to request for any additional information and also reserves the right to reject the proposal of any bidder if, in the opinion of owner, the qualification data furnished by the bidder is incomplete or the bidder is found to be not qualified to perform the supply satisfactorily. Notwithstanding anything stated above, the Corporation reserves the right to assess bidders' capability and capacity to perform the supply, should the circumstances warrant such an assessment, in the overall interest of the Owner.
- 4. Each bidder shall submit only 1 (one) bid, against each NIT. A bidder who submits or participates in more than 1 (one) bid in each NIT will be disqualified.

5. RATE PER UNIT BASIS:

- 5.1 Bidders shall quote their rates against respective item specification in the prescribed format given under Section VI of the Bid Document.
- 5.2 The Hire-charge rate, excluding the driver's salary for the scope of work shall be "FIRM" till completion of contract. No escalation of the hire-charge rates will be admissible.
- 5.3 However, the salary of driver shall be subject to change as per the minimum wages prescribed by the Govt of India and adopted in PLHPS.
- 5.4 <u>Taxes, Duties & Levies</u>: The quoted rate shall be inclusive of all Taxes and duties as admissible but excluding GST which shall be indicated in the space of the prescribed format given in the price bid.

- 5.5 Bidders are to quote unit rates in figures and words for the items indicated in Section VI of Bid document. The Bided amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation.
- 5.5 If the Bidder does not accept the corrections made as above, his Bid will be rejected and the EMD submitted will be forfeited. Erasing, over writing, changes and cuttings shall be initialled by the Bidder.
- 6. Period of Contract: The supply of the vehicle has to be placed within 60(sixty) days from the date of issue of the supply order. Upon acceptance of the vehicle by the Consignee, the engagement of the vehicle shall be done for 03 (three) years from the date of placement of the vehicle to the concerned Official of the Plant. However, the order shall be issued initially for a period of 01(one) year and for rest of the contract period the order shall be issued for one year at a time with same rate and T&C, depending on the condition of the vehicle.
- 7. Earnest Money: An earnest Money amounting to Rs 75,000.00 (Rupees Seventy-Five Thousand) only shall be paid online through SB collect, the details of which is given in the section Instruction to Bidder at Clause. No. 6. Documentary evidence of the EMD submitted online to be enclosed with the Techno Commercial Bid, failing which the bid shall not be considered.

8. Issue of Tender Document

- 8.1 Non-transferable Bid documents can be obtained from the Office of the Dy. General Manager (HR), PLHPS, NEEPCO, Yazali, Arunachal Pradesh, India on submission of application addressed to the Dy. General Manager (HR), PLHPS by paying non-refundable bid fee of ₹1,180.00 (Rupees One Thousand One Hundred and Eighty) only in favour of NEEPCO Ltd., Yazali. The Bid Document shall be obtained from the office of the Dy. General Manager (HR), PLHPS, Yazali, Arunachal Pradesh, on all working days w.e.f. 06.11.2025 from 10:00 Hrs to 17:00 Hrs. The last date of issue of Bid Documents is 25.11.2025 till 12:00 Hrs.
- 8.2 Only those bidders to whom NITs have been issued shall request for issue of detailed bid document. Issue of Bid documents shall not necessarily qualify the purchaser to qualify for consideration for the Tender.
- 9. Compensation for Delay in supply of Vehicle: In case of delay in supply of the hired vehicle within the stipulated period indicated in clause no.6 above, compensation for delay at the rate of 0.5% (zero-point five percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of 10% (Ten percent) of the contract price. The deduction shall be made from the monthly bill of hire charge.
- 10. NEEPCO reserves the right to reject any or all bids or cancel/withdraw the invitation for NIT without assigning any reason thereof and in such case no bidder/intending bidder shall have any claim arising out of such action.
- 11. Bidder/Bidders are advised to study the Bid document carefully before submitting the Bid form. It will be presumed that the Bidder /bidders have considered and accepted all the terms and
