

**NOTICE INVITING TENDER**

The North Eastern Electric Power Corporation Limited (NEEPCO), a Public Sector Enterprise under the Ministry of Power, Government of India invites tender for the following work of AGBP as detailed below.

**1.0 QUALIFYING REQUIREMENTS OF BIDDERS:**

**1.1 The bidders shall have the following Qualifying Criteria:**

The bidders shall have to submit the following particulars along with their bid. Without the following documents, the bid shall not be considered to any intending firm(s)/ contractors and bid will be rejected and their bid will be considered as disqualified bid.

(i).Experience of having successfully completed similar nature of works under State Govt./ Central Govt./PSU during last 7 (Seven) years (ending on last day of the month previous to the one in which applications are invited) should be either of the following. The bidder shall have to submit the bid along with earlier work order copy of similar nature & completion certificate of said work, otherwise, the bid shall be rejected.

- One completed work costing not less than the amount equals to 80% of the Tendered value OR
- Two completed works each costing not less than the amount equal to 50% of the Tendered value OR
- Three completed works each costing not less than the amount equal to 40% of the Tendered value.

**2.0 GENERAL REQUIREMENTS:**

- Registration for GST
- PAN (Permanent Account Number) for Income Tax
- Trade License

**3.0 BID FEE (Off-Line):** Bidders shall have to deposit BID FEE (Non-refundable) for participation in this instant tender of Rs. 224.00 (Rupees Two hundred & twenty four) only including GST (as applicable as per Govt. rule). The cost of tender document shall deposited through "SB COLLECT" in to Neepeco (AGBP) SBI Account (Non-refundable) drawn in favour of "NEEPCO Ltd., Bokuloni, Dibrugarh, Assam.



**4.0 EARNEST MONEY DEPOSIT (EMD) Off-Line:** Bidders shall have to deposit Earnest Money (EMD) as mentioned above in the NIB. The Earnest Money shall be deposited through "SB COLLECT" in to Neepeco (AGBP) SBI Account drawn in favour of "NEEPCO Ltd., Bokuloni, Dist. Dibrugarh, Assam.

**5.0 The procedure/steps for payment by SB-COLLECT of State Bank of India (for payment of BID FEE, EMD ) in to NEEPCO (AGBP) SBI Account as follows:**

1.	Visit "On line SBI.com"
2.	Go for "SB COLLECT" icon on top
3.	Read Accept the terms & condition and proceed
4.	Select "Assam" against State of Corporation
5.	Select "PSU" against type of Corporation & go to NORTH EASTERN ELECTRIC POWER CORPORATION LTD" then submit
6.	Select "AGBP parties" & submit
7.	Feed Necessary information in the appropriate boxes
8.	Payment through "Internet Banking" SBI Branch, SBI Buddy or Card Payment etc.
9.	Print Copies of receipt and submit

**6.0 IMPORTANT INFORMATION AND DATES:**

Bid Fee:	INR 224.00 (Rupees Two hundred & twenty four) only.
Bid validity:	180 (One Hundred & eighty days) only.
Bid Selling Start Date & Time:	From 11:00 Hrs of 25.05.2022 upto 16:00 Hrs of 27.04.2022
Bid submission Date & Time::	From 10:00 Hrs to 16:00 Hrs of 11.05.2022
Bid Opening Date & Time:	At 16:00 Hrs of 12.05.2022

In case any of the above mentioned date is declared as a closed holiday for NEEPCO, the next working day shall be considered for the purpose.

**7.0. For MSMEs :**

The MSMEs shall have to provide valid exemption certificate if any against payment of Bid Fee & EMD.
