The undersigned on behalf of "North Eastern Electric Power Corporation" (NEEPCO) hereby invites sealed tender with a validity of 180(One Hundred Eighty) days from experienced/reputed/perfect, preferably PLHPS Registered Contractors for execution of "Internal Wiring of PLHPS Damsite Office Building, NEEPCO at 41Km, Yazali(A.P)", against the item specifications indicated in Bid document. The brief Terms & conditions are herein under:

## Scope of the Work:

The work to be executed as per Technical Specification attached in the Tender Document and as mentioned in the Schedule of Items enclosed in **Annexure** –I of the Bid Document. Moreover, instruction of Site Engineer is final and binding.

# Rate per unit basis:

- 2.1 Rate for the scope of carrying out respective item specification shall be "FIRM" till completion of work irrespective of any quantity variation either upward or downward, i.e. Plus or Minus. No escalation of rates will be admissible under any circumstances.
- 2.2 Bidders are to quote unit rates in numerical figures and words for the items indicated in Annexure-I. The tendered amount shall be legibly written in English in ink, in Indian currency both in numerical figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and award of work. Erasing, over writing, changes and cuttings shall be initialled by the bidders.
- 2.3 In case of any discrepancy between the quoted rates in figures and words, the rates quoted by the tenderer in words shall prevail and these rates shall be considered accordingly.
- 2.4 Taxes, Duties & Levies: Bidders shall quote their rates against respective item specification inclusive of all taxes and Duties including Forest Royalty, Monopoly charges, Service Tax, and Building Cess etc. No extra charge on this account shall be paid by the corporation. The corporation will treat the quoted rates as final and inclusive of all components & taxes etc. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work.

#### 3. Estimated Amount:

3.1 5,56,591.00 (Rupees five Lakhs Fifty-Six Thousand Five Hundred Ninety-One) only to show the probable cost of the work. The amount is inclusive of all applicable taxes. However, the bidder is to get acquainted with the taxes as applicable before quoting his rates.

# **Payment Terms:**

- Payment (Running Interim/Advance) will be released after satisfactory completion of work as certified by Engineer-In-Charge. No advance payment will be entertained.
- 90% (Ninety Percent) payment shall be made on successful completion of works certified by Engineer- In-Charge. Payment will be made after deducting the applicable taxes & duties and other recoveries, if any. No running bill shall be admissible. Kindly submit the bill in triplicate in the GST format along with completion certificate.
- 10%(Ten Percent) of the total contract value shall be retained as Performance Guarantee which shall be released after the expiry of defect liability of the contract. In case of any defect in the work is detected within defect liability period, shall be made good by the Contractor at his own risk and cost. No extra payment shall be made by the Corporation.
- 4.4 As the payment is to be made under 'e-payment' system, the following details are to furnished at the time of submission of the tender: ISO 9001-2008, 14001-2004 BS OHSAS-18001-2007 .
  - Name and complete address of your firm as per the bank account.
  - Complete address of the bank with Branch details.
  - Type of Bank account (Saving/Current/Cash Credit)
  - Bank Account Number (indicating Core Banking Account Number) if any
  - IFSC/NEFT code (11 Digit)/MICR code as applicable
  - Email I.D. so that payment can be intimated to you.

# Time of Completion:

The time of completion of work shall be 30(Thirty) days from the date of issue of work order.

- 6. Paying Authority: The Deputy Manager (F), F&A wing, PLHPS, NEEPCO Ltd, Yazali (A.P).
- 7. Store issue: -All materials are to be supplied by the contractor.

# Compensation for Delay:

In case of delay in completion of work within the stipulated period indicated in clause no.4 above, compensation for delay at the rate of ½%(half percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of 10% (Ten percent) of the contract price. The deduction shall be made on the balance quantity of work that remains to be executed.

The works shall be subjected to a defect liability period of 12(Twelve) months from the date of **Defect Liability Period:** completion of work in all respect. Any defect in the work, detected during or after the completion of the work within the defect liability period, shall be made good by the contractor at his own risk and cost, and no extra payment shall be made by the corporation. The nature and extent of defects to be considered for the purpose of Defect Liability, shall be decided by the Head of Project/Engineer-In-Charge and decision of Head of Project/Engineer-In-Charge in this matter shall be final and binding. On expiry of 6(Six) months from the date of completion, the defect Liability Certificate shall be issued by the Engineer-in-charge. Sr. Manager(E/M), US&W shall be the Engineer-In-Charge of this work.

# 10. Security Deposit:

As security for the defect liability period, Security Deposit amounting to 10% (Ten percent) of the work value shall be retained for 12(Twelve) months from the certified date of completion and the same shall be released after expiry of defect liability period or defect rectification work if any arises or payment of final bill whichever is later.

The tenderers are requested to inspect and examine the site prior to submission of the bid. The corporation bears no responsibility for lack of acquaintance of the site conditions and any information relating thereto on the part of the tenderers.

- The detailed information regarding the skilled manpower, plant and machineries to be engaged in execution of the work.
- Bidder must have Valid Credentials of Manpower having Electrical Supervisor/Workman Licence under him. Undertaken to this effect, documentary evidence is to be submitted alongwith the bid.

#### 15. EXEMPTIONS FOR MSME's:

- 15.1.1 Exemptions for MSME's shall be applicable under the Govt. of India norms under PPC guidelines.
- 15.1.2 The Bidder registered as Micro/Small Enterprise are exempted from paying applicable bid fee, Earnest Money Deposit (EMD) subject to submission of valid and relevant document/certificate.
- 15.1.3 The Price preference as applicable to MSME's as per Govt. of India Norms, during evaluation of the Bid shall be applicable. A copy of the MSME registration is to be submitted along with the Techno-Commercial Bid.

Incomplete submission of document as stipulated in the clause no 13 mentioned above will lead to cancellation of the tender.
