1. E-Tendering / E-Procurement

This tender is being processed through e-tendering system. The bidding documents are to be downloaded from https://etenders.gov.in and bids are to be submitted/uploaded through above e-tendering system. Guidelines for e-tendering system are available on e-tender portal.

2. Registration for Participation in Bids:

- 2.1 Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://etenders.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2.2 As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 2.3 Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 2.4 Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 2.5 Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 2.6 Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC/e-Token

All the bidders are requested to get themselves registered well in advance and no extra time will be considered for submission of bids for the delay in on-line Bidder Registration, if any.

The proposed building should have a Corporate Office look. The bidder shall ensure that the proposed construction cost of the complete building shall be approximately Rs.1.5 cr.

- 8. Assessment: The Technical Evaluation shall be done on the basis of the submittals furnished in the Techno-Commercial Bid. Having all the requisite credentials as per the General Requirements as well as per General Condition, the preliminary proposal of the Bidder shall be examined by NEEPCO and the accepted offers shall be considered for Price Evaluation. The bidder may require to give a power-point presentation on their proposal if NEEPCO desires so. The decision of NEEPCO in this regard shall be final and binding on the bidders.
- The Bidders, who will meet the qualification requirement as per NIT for Techno-Commercial Bid, will be communicated for opening of Price bid.
- Special Conditions:

The bidder who will qualify technically, but could not qualify in the Price Bid, will be paid Rs. 5,000.00 (Rupees Five Thousand) only to compensate for the input works of preliminary submission on production of Bill. No. 5 (ii)(a to g) shall be treated as disqualified.
