## Notice Inviting Tender No – 37/2018-19 Dtd. 18/09/ 2018.

The undersigned, on behalf of the Corporation hereby invites sealed tender under Single stage Two Envelope system through Domestic Competitive Bidding (DCB) route with a validity of 180 (One Hundred Eighty Days) from experienced/reputed contractors for execution of the work of "Day to Day maintenance & Annual Planned Maintenance of 3 x 135 MW Vertical Francis Turbine and Generator, Bus duct, Associated 132 KV & 400 KV Switchyard including Step-up Generator Transformers, 400 KV Auto Transformers, Reactors, Station Service Transformers and all other ancillary/auxiliary equipments of Ranganadi Hydro Electric Plant." as detailed herein under:

- 1. <u>Scope of work</u>: The scope of work shall be regular and periodical maintenance including Day to Day maintenance & Annual Planned Maintenance of 3 x 135 MW Vertical Francis Turbine and Generator, Bus duct, Associated 132 KV & 400 KV Switchyard including Step-up Generator Transformers, 400 KV Auto Transformers, Reactors, Station Service Transformers and all other ancillary/ auxiliary equipments of Ranganadi Hydro Electric Plant. The terms and conditions governing this tender are detailed in the subsequent sections of the Bid Document.
- **2. Period of Contract.** The period of will be 27(Twenty-seven) months from the date as specified in the detailed work order.

## 3. **Qualifying requirements**:

- a) Technical: The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.
- (i) The participating bidders should enclose copy of any one of the following documents in support of its credential.
  - (a) Trade License / Municipal License issued by competent authority in case of a sole proprietary firm.
  - (b)Partnership deed in case of partnership firm
  - (c) Certificate of Incorporation in case of a Company.
- (ii) The bidder shall have experience of erection & commissioning of vertical hydro turbine generating units (Francis Turbine with Semi Umbrella type hydro generator) of minimum capacity 100 MW in a single power house.
- (iii) The bidder shall have experience in executing annual maintenance works & day to day Maintenance works for a minimum period of 5(Five) years in any power house of minimum capacity of 100 MW (single machine) in a row of three machines or more. The maintenance works shall be executed in Francis Turbine with Semi-Umbrella type Hydro-Generator units.
- (iv) The bidder shall also have executed maintenance works in associated Switch Yard of the Power Houses which are of 400 kV voltage class level having a capacity of more than 300 MW.
- (v) The above experiences should be of any Projects under Government / PSUs Organisation. Completion/Experience certificate issued by the competent authority should be submitted by bidders along with Techno Commercial Bid.
- (vi) The Bidder shall have executed similar works in the last 6 (six) Years in the following category:
  - A. At least 3(Three) similar works amounting to ₹. 3,25,00,000.00 each

Or

B. At least 2(Two) similar works amounting to ₹. 4,85,00,000.00 each

or

C. At least 1(One) similar work amounting to ₹. 6,50,00,000.00

- (vii) Details like valid, PF code, PAN number, Bank account No (along with IFSC code) & Service Tax code number & License under Contract Labour Regulation & Abolition Act 1970 should be submitted along with the Bid document.
- (viii) The bidder should possess valid EPF registration under EPF&MP Act, 1952 with code number and a copy of the same should be enclosed along with the Bid document.
- b) Financial: The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.

### (i) Minimum Average Annual Turn Over (MAAT):

The average annual turnover of the bidder in the best 3 (three) financial years out of the last 5 (five) years financial year should not be less than ₹. 5.50 Crores (Rupees Five Crores Fifty Lacs).

#### (ii) Audit Reports:

Complete Audited Annual Reports along with Audited Balance Sheets, Profit and Loss Account and other financial statements for the preceding 3(three) financial years, ending 31st March 2018. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be considered acceptable. The Audited reports should indicate the turnover as specified above.

### (iii) Letter of adequacy/solvency.

Letter of adequacy/ solvency and commitment not older than 06 (six) months for an amount of Rs. 8.10 Crores from their Bankers/Financial Institutions should be furnished along with their bids.

- c) Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 3.0 above shall be submitted along with the containing Techno-Commercial bid along with Bid Guarantee. For qualifying requirements specified at Para 3 above, the documents should be uploaded in the prescribed format of the Techno Commercial Bid duly signed by the authorized signatory. Bids submitted without fulfilling the qualifying requirements shall be rejected.
- d) Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by any Govt. / PSU department.
- e) The above requirements are minimum and the Corporation reserves the right to request for any additional information and also reserves the right to reject the proposal of any bidder if, in the opinion of owner, the qualification data furnished by the bidder is incomplete or the bidder is found to be not qualified to perform the work satisfactorily.
- f) Notwithstanding anything stated above, the Corporation reserves the right to assess bidders" capability and capacity to perform the work, should the circumstances warrant such an assessment, in the overall interest of the Owner.
- g) Each bidder shall submit only 1 (one) bid, either individually. A bidder who submits or participates in more than 1 (one) bid will be disqualified

#### 4. E-Tendering / E-Procurement :

This tender is being processed through e-tendering/e-procurement system. The bidding documents are to be downloaded, filled in bids are to be submitted/ uploaded through e-tendering system of NEEPCO Ltd. at https://neepco.abcprocure.com.

#### 5. Participation in Bids:

- 5.1 **Portal Registration**: The bidders intending to participate in the e-tendering and download the detailed bid document have to register themselves in the portal https://neepco.abcprocure.com. Relevant information about the bidder required during the registration is available in the portal.
- 5.2 Vendor registration fee: The fees for Vendor Registration in the portal is ₹. 3000.00(Indian Rupees three thousand) only per year (Non- Refundable). Bidders who are already registered in the system shall ensure to keep their registration valid till completion of the entire bidding process.

Bidders shall make payment of vendor registration fee of ₹. 3000.00 (Indian Rupees Three Thousand only) online through "SB Collect" detail procedure/steps is given in the Section C Instruction to Bidders at Sl. No. 12.1.

#### 6. Procedure for Payment of BID Fees and EMD:

- 6.1 Bid Fees
  - a) Bidder shall make payment of non refundable Bid fees of amount ₹. 5900.00 (Rupees Five Thousand Nine Hundred) only inclusive of 18% GST online through "SB Collect" details of which is given in the Section C: Instruction to Bidders at Sl. No. 10 & 12.2.
- 6.2 EMD: Bidders may submit the EMD in either of the following ways.
  - 6.2.1. Through SB Collect.
  - a) Bidder can make payment of refundable EMD of amount ₹. 16,50,000/- (Rupees Sixteen Lacs Fifty Thousand) only online through "SB Collect" details of which is given in the Section C: Instruction to Bidders at Sl. No. 11.1& 12.2.
  - 6.2.2 Through Bank Guarantee.
  - a) Bidders can also make payment of EMD in the form of Bank Guarantee from a nationalised/scheduled bank for an amount of `. 16,50,000/- (Rupees Sixteen Lacs Fifty Thousand) only, details of which have been specified in Section C: Instruction to Bidders at Sl. No. 11.2.
- 6.3 <u>a) Exemptions for MSME's shall be applicable under the Govt. of India norms under PPC guidelines.</u>
  - b) Also the Price preference as applicable to MSME's as per Govt. of India Norms, during evaluation of the Bid shall be applicable.
