2. **Scope of work**

- (i) **220 kV GAS INSULATED SWITCHGEAR (GIS) with GAS INSULATED BUS DUCT (GIB)**

The scope of works under the contract covers design, manufacture, supply and transportation up to site, handling and storage at site, erection, testing and commissioning of one (1) 220 kV Gas Insulated Switchgear (GIS) & required Gas Insulated Bus Duct (GIB), spare parts for five (5) years trouble free operation, special tools and tackles and as described in the specification. The 220 kV Gas Insulated Switchgear GIS & GIB will be installed in the powerhouse of the HEO HEP, the latter erected on the left bank of Yarjep (Shi) river located in District Shi Yomi, Arunachal Pradesh.

The layout shall be generally as shown on the drawings however, subject to the provisions of this specification and approval of the Engineer, these may be adjusted as necessary to suit the manufacturer's standard design.

The Gas Insulated Switchgear (GIS) will be the 220 kV Substation, installed in the GIS Hall (EL more than 1000m) located above transformer hall, in the GIS Building.

The Gas Insulated Switchgear (GIS) Bays shall be connected directly to respective generator transformers (GTs) and SST located in transformer hall and to respective SF6 to Air Bushings located in pot head yard, through Gas Insulated Bus (GIB).

The switchyard layout shall be designed to accommodate future extension, including space provision, for one 50 MVA reactor bay and two future outgoing feeder bays.

**(ii) Scope of Work (POTHEAD YARD EQUIPMENTS):**

The scope of works under the contract covers the design, manufacturing or manufacture co-ordination, testing at manufacturer's works, ex-works supply, loading at manufacturer's works, insurance, transportation, and destination store delivery, erection testing & commissioning of following equipment along with their accessories for 220 kV pothead yard near Power House. All the required accessories, documents & equipment whether specified herein or not shall be in the scope of the bidder.

The scope shall also include supply of special tools & plants required for the erection, testing and commissioning of 220 kV pothead yard equipment and also supply of mandatory spares required for maintenance of supplied equipment for five years trouble free operation. **5. Earnest Money Deposit/ Bid Security:**

The Earnest Money Deposit shall be INR 71 Lakh (Rupees Seven One Lakh ) only. The EMD shall be paid /deposited as per the procedure given in Sec-III of the Bid Document. Bids without or insufficient EMD shall be rejected.
