### Notice Inviting Tender No. – PLHPS/HOP/04/2023-24 Dtd. 19.06.2023

The undersigned on the behalf of North Eastern Electric Power Corporation Ltd (NEEPCO), a Public Sector Enterprises under the Ministry of Power, Govt. of India invites sealed two part bids from the Reputed firms in single stage two envelope bidding system with minimum 180 (One hundred & Eight) days validity for "Complete overhauling of 4 Numbers Sliding Draft Tube Gate of Unit-1 &2 including supply of component along with a fitting of supplied components in existing system, servicing, testing and re commissioning at 3X135 MW Dikrong Power House, Panyor Lower Hydro Power Station, NEEPCO Ltd., Hoj, Arunachal Pradesh" as per and terms & conditions indicated in the Bid Document.

#### **SCOPE:** 1.

- The scope of work shall be the complete overhauling of 4 Numbers Sliding Draft Tube Gate i) of Unit-1 &2 including supply of components/ spares along with fitting of supplied components in existing system. The details of supply of components required for complete overhauling is enclosed at Annexure-A
- The scope of work shall also include the Servicing, Testing and Re-commissioning of the 4 nos DT Gates at 3X135 MW Dikrong Power House, Panyor Lower HP Station, NEEPCO Ltd., Hoj, Arunachal Pradesh. The details of the Service activities are enclosed at Annexure-
- iii) The T&P required for carrying out the work of the overhauling of the DT gates shall be under the scope of the contractor. Any special T&P required against the work, detailed under Annexure – C, shall be provided by the Corporation.
- iv) The scope shall also include the Freight & Insurance of the delivered components up to delivery at site.

#### 2. **COMPLETION TIME:**

**2.1 Supply Part:** The delivery of the materials shall be completed within 60 (sixty days) Days from the date of issue of detail order. The complete drawing of the materials/ equipments to be supplied shall be submitted for approval within three weeks from the date of issue of order.

#### 2.2 Servicing, Testing & Re-Commissioning:

The complete overhauling, fitting of supplied components in existing system, servicing, testing and re-commissioning of 4 Numbers Sliding Draft Tube Gate of Unit-1 &2 at 3X135 MW Dikrong Power House, Panyor Lower HP Station shall be completed within 02 (Two) months from the date of receipt of materials at site & on intimation from this end. The Erection, Testing and Commissioning shall be completed to the satisfaction of the Engineerin- Charge of this contract. Any other works not specifically indicated in the BOQ but required for the commissioning of the erection & commissioning of the DT shall be under the purview of this contract which shall be completed by the contractor.

#### 3. **QUALIFYING REQUIREMENT:**

- a) **TECHNICAL:** The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.
- (i) Trade License of the firm in case of reputed firms showing his credential as a firm dealing with erection, repairing or maintenance of mechanical or Hydraulic Gates.
- (ii) Certificate of incorporation in case of a company, partnership deed in case of a partnership firm as the credential of the firm.
- (iii) The bidders shall attach the following in support of his credentials:
  - (a) The bidder shall have executed any erection works in the following category of any mechanical /hydraulic gated of size not less than 4300X2800 mm in the last 3 (three) years.

Or

- (b) The bidder shall have executed any maintenance works of any mechanical /hydraulic gated of size not less than 4300X2800 mm for a period of 06(six) months or more in the last 3 (three) years.
- (iv) The bidder shall also submit the following in support of the Technical Qualifying Requirement.
  - (a) A single order of either an erection job or a maintenance job of Mechanical/ Hydraulic Gates not less than ₹ 150.00 lacs executed by the firm to any Govt. /PSUs organizations/reputed organisation in the order in the last 03(three) years and the bidder shall submit the copy of the said supply order along with completion certificate duly endorsed by the executing authority.

or

(b) Two orders of either an erection job or a maintenance job of Mechanical/ Hydraulic Gates not less than ₹ 110.00 lacs executed by the firm to any Govt. /PSUs organizations/reputed organisation in the order in the last 03(three) years and the bidder shall submit the copy of the said supply order along with completion certificate duly endorsed by the executing authority.

or

- (c) Three orders of either an erection job or a maintenance job of Mechanical/ Hydraulic Gates not less than ₹ 75.00 lacs executed by the firm to any Govt. /PSUs organizations/reputed organisation in the order in the last 03(three) years and the bidder shall submit the copy of the said supply order along with completion certificate duly endorsed by the executing authority.
- (v) Details like valid PF code, PAN number, Bank account No (along with IFSC code) & GST Registration No & License under Contract Labour Regulation & Abolition Act 1970 should be submitted along with the Bid document.
- (vi) The bidder should possess valid EPF registration under EPF&MP Act, 1952 with code number and a copy of the same should be enclosed along with the Bid document

The documents submitted in support of the credential should be valid till the opening of the Bid as specified in the Tender.

#### b) FINANCIAL:

The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.

- (i) Annual turnover by the firm in the best three financial years out of last five financial year ending March 2023 should not be less than ₹ 500.00 Lacs.
- (ii) Solvency certificate, not older than 6 months, by the firm from a nationalized / scheduled bank specifying the firm is financially sound to execute the contract amounting to ₹ 200.00 Lacs.

- c) Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 3.0 above shall be submitted online along with the Techno-Commercial bid under Envelope I, Bids submitted without fulfilling the qualifying requirements shall be rejected.
- **d**) The above requirements are minimum and the Corporation reserves the right to request for any additional information and also reserves the right to reject the proposal of any bidder if, in the opinion of owner, the qualification data furnished by the bidder is incomplete or the bidder is found to be not qualified to perform the work satisfactorily.
- **e)** Notwithstanding anything stated above, the Corporation reserves the right to assess bidders' capability and capacity to supply the item, should the circumstances warrant such an assessment, in the overall interest of the Owner.
- **f**) Each bidder shall submit only 1 (one) bid. A bidder who submits or participates in more than 1 (one) bid will be disqualified.
- g) Bidders as a consortium shall not be allowed to participate in this bid.
- **h)** The bidders shall not have been blacklisted by any Govt./Govt. agency in India. A Self declaration to that effect should be submitted along with the technical bid.

#### 7. PROCEDURE FOR PAYMENT OF BID FEES & EMD:

#### 7.1 Bid Fees

- a) Bidder shall make payment of non-refundable Bid fees of amount ₹ 2,360.00 (Rupees Two Thousand Three Hundred Sixty) only inclusive of GST @18% online through "SB Collect" details of which is given in the Section-II Instruction to Bidders at Sl. No. 8.1. A copy of payment receipt to be uploaded in the e-tendering site falling which the bid shall not be considered. Further Documentary evidence of the Bid Fees paid shall accompany the Technical Bid. The invoice against the Bid Fee shall be submitted to the bidder after opening of the e-tender.
- b) Bids received online without Cost of Bid Documents unless exempted shall be rejected.
- c) <u>Please ensure that payment of Bid Fee is made under "RHEP PARTIES" only in SB Collect.</u>

d) Payment of bid fee in any other mode will not be accepted.

#### 7.2 **EMD**:

#### 7.2.1 Through SB Collect

a) Bidder shall make payment of refundable EMD of amount ₹ 3,50,000/- (Rupees Three Lacs Fifty Thousand) only online through "SB Collect" details of which is given in the section Instruction to Bidder at Sl. No. 8.1. A copy of payment e-receipt to be uploaded in the e-tendering site falling which the bid shall not be considered.

#### 7.2.2 Through Bank Guarantee

- a) Bidders can also make payment of EMD in the form of Bank Guarantee from a nationalised/scheduled bank for an amount of ₹ 3,50,000/- (Rupees Three Lacs Fifty Thousand) only, details of which is given in the section Instruction to Bidder at Sl. No. 8.2
- 7.2.3 If submitted through Bank Guarantee, receipt of off-line documents should be before the specified date.
- 7.2.4 Bids received online without EMD unless exempted shall be rejected.
- 7.3 Exemptions for MSME's shall be applicable under the Govt. of India norms under PPC guidelines.
