The North Eastern Electric Power Corporation Limited (NEEPCO), a Public Sector Enterprise, invites Single-Stage Two- Envelope Bids from Reputed Manufacturers/ Manufacturer's Authorized Distributors or Dealers/ Reputed firms for overhauling and up-gradation of existing CO2 Firefighting System of 3 x 25 MW Doyang Power House, NEEPCO, Doyang, Wokha-Dist, Nagaland.

Site Survey, design, drawing, engineering, manufacturing, supply, erection, up-gradation, testing and commission of complete Automatic Stationary CO2 Fire-fighting system for all three Generators of Doyang Power Station including testing and filling of new gas of 32 nos of CO2 cylinders as per site requirement. The system should be fully automatic including proper function of smoke and heat detectors, all types of valves, discharge head, discharge manifold, frame & accessories, switches, Control panels, junction boxes, wiring copper cables with fire retardant, door limit switch, hooter/bell, remote annunciation, pipe lines & connectors etc. whatsoever required to complete the system as per the site requirement. General information:

3 X 25 Mw Doyang Hydro Power Station is situated in Doyang, Wokha District of Nagaland State, about 120 km from Dimapur via Merapani, Assam. The nearest railhead is Furkating Junction, Assam, about 60 Km from Doyang. The nearest airports are Dimapur & Jorhat.

1. QUALIFYING REQUIREMENTS

1.1 Technical

- (i) Bidders must be a reputed manufacturer/ Manufacturer's Authorized Distributors or Dealers/ Reputed firms and must have experience in undertaking similar nature of job to any Government Department or Organization /Public Sector Undertaking. The bidder should have successfully executed/completed similar work during the last 7 (seven) years, ending last day of the month previous to the date of NIB having minimum order values as indicated below:

- (a) Three similar completed works costing not less than **Rs.9,65,000.00** each.

OR

- (b) Two similar completed works costing not less than **Rs. 12,05,000.00** each.

OR

- (c) One similar completed work costing not less than **Rs.19,30,000.00**.

Order copies along with Completion Certificates issued by respective authority must be submitted in support of similar work along with the bid.

Similar Work here means renovation/supply, installation, testing and commissioning of Automatic Stationary CO2 Firefighting system during the last 7 (seven) years.

- (ii) The bidder should not have been blacklisted by any Government/Government agency in India. Self declaration to that effect should be submitted along with the bid.

1.2 Financial

- i) **Minimum Average Annual Turnover (MAAT):**

The Average Annual Turnover of the Bidder in the best 3(three) years out of the last 5(five) financial years, should not be less than **Rs.36, 00,000 (Rupees thirty six lakhs) only**. Other income will not be considered for arriving at annual turnover. Complete audited annual reports with balance sheets for the last 5 (five) years should be furnished along with the bid. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be considered acceptable.

- ii) **Liquid Assets:-**

The bidder should have liquid assets or/and evidence to availability of unutilized credit facilities of not less than **Rs.20,00,000 (Rupees twenty lakhs) only**. Letter of adequacy / solvency commitment from their bankers/financial institutions should be furnished along with the bid. Relevant certificates should not be dated earlier than one month from the date of bid.

- iii) Documentary evidence in support of the above must be submitted along with the bid.

- iv) The bidder shall also submit the following documents in their bid in order to ensure qualification:

- i) Copy of PAN card.
- ii) GST registration Certificate.
- iii) Copy of audited annual accounts for the last five years.

Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 1.1 & 1.2 above shall be submitted in Sealed Envelope-1, containing Techno-Commercial bid. Bids submitted without fulfilling the qualifying requirements shall be rejected
