SHORT NOTICE INVITING TENDER (NIT)

North Eastern Electric Power Corporation Limited, a leading Miniratna Category-I Public Sector Enterprise under the Ministry of Power, Government of India, invites sealed bids from selected bidders under Single-Stage Single-Envelope bids for "Construction of temporary security fencing around Colony Area, Tato-II HEP, Arunachal Pradesh."

1. **Name of the Work:** Construction of temporary security fencing around Colony Area, Tato-II HEP, Arunachal Pradesh
2. **BIDDING PROCEDURE:** The Bidder shall submit Bids under Single-Stage Single-Envelope bidding system. Single envelope shall contain Earnest Money Deposit (EMD), documents in support of Qualifying Requirements, Techno-Commercial Bid and Price Bid.
3. **Rate per unit basis:** No price adjustment of quoted rates/prices, on account of any rise in prices of any material, labour, POL etc. shall be admissible under any circumstances in respect of any item of work during the period of contract.
4. **Estimated Amount:** Rs. 29,99,553.00 (Rupees Twenty Nine lakh Ninety Nine Thousand Five Hundred and Fifty Three only) inclusive of Building Cess, GST and Other Taxes & charges.
5. **Payment Terms:**
 - 5.1 Payment (Running Interim/ Final) will be released after satisfactory completion of work as certified by the Engineer-In-Charge. No part payment/ advance payment will be entertained.
 - 5.2 90 % Payment will be released on successful completion of the work. Balance 10 % will be kept as Performance Guarantee/ Security Deposit, which will be released after expiry of defect liability period for the work. In case of any defect in the work detected after the completion of the work within the defect liability period, shall be made good by the contractor at his own risk and cost, and no extra payment shall be made by the corporation.
6. **Paying Authority:** The paying authority shall be Head of Finance, GM (FIN), Tato-II H.E. Project, Tato, Shi Yomi, A.P.
7. **Time of Completion:** The work shall be completed within **03 months** from the date of issue of the work order.
8. **Compensation of Delay:**

In case of delay in work of items within the stipulated period indicated in clause no. 8 above, compensation for delay at the rate of 0.5 % of the contract price shall be deducted for per week or part thereof of delay subject to maximum of 10 % (Ten percent) of the contract price.
9. **Defect Liability Period:**

The works shall be subjected to a defect liability period of 1 (One) year from the date of completion of work in all respect. The nature and extent of defects to be considered for the purpose of Defect Liability, shall be decided by the Head of Project/ Engineer-In-Charge and decision of Head of Project/ Engineer-In-Charge in this matter shall be final and binding. On expiry of defect liability period a certificate in this regard shall be issued by the Engineer-In-Charge. In case on non-compliance of clause no. 5.2 the security deposit shall be forfeited.

10. **Security Deposit:**

10 % (Ten percent) of the work value shall be retained as security deposit and the same shall be released after expiry of defect liability period or defect rectification work if any arises whichever is later.

11. **EARNEST MONEY DEPOSIT:** Earnest Money Deposit of Rs. 60,000.00 (Rupees Sixty Thousand only) shall be in the form of Demand Draft /Banker's Cheque from a Nationalized bank/Schedule Bank drawn in favour of NEEPCO payable at Guwahati.

EMD of unsuccessful bidders will be returned on award of work order to the successful Bidder. Tender submitted without EMD shall be rejected outright.

12. **SCOPE OF WORK:**

The Scope of work will include construction of temporary security fencing around Colony Area, Tato-II HEP, Arunachal Pradesh. The broad Scope of work will include the following:

- Earth work in excavation in foundation and trenches of size 500 mm x 500 mm x 600 mm for fixing of pillars.
- Transportation of construction materials Viz. Cement, Steel, Sand, Aggregates, water, scaffolding/formwork etc to work site.
- Providing and erecting angle fencing posts of size 50x50x4 mm and/or as indicated in the drawings.
- Fixing of barbed wire fencing along the outer periphery of the entire colony area.
- Painting of the angle posts.

13. **QUALIFYING REQUIREMENTS:**

The Bidder shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirements along with the bid document submitted.

- a. Copy of Income Tax PAN Card
- b. Copy of GST registration.
- c. EMD as per above clause no. 11
- d. Certified copy of EPF registration under EPF& MP Act, 1952 with code number.
- e. Successful bidder will have to submit the following along with the final bill/ invoice for effecting e-payment.
 - i. Name & complete address of your firm as per bank record.
 - ii. Complete address of the Bank with Branch details.
 - iii. Type of Bank Account (Saving/ Current/ Cash Credit)
 - iv. Bank Account Number
 - v. IFSC code / MICR code as applicable
 - vi. Email address of the vendor/ authorized official along with mobile number (for receiving the update status of payment) if any.

14. **Submission and Opening of Bids:**

- a) **Single Envelope Procedure:** The Bid shall be packed in a single envelope and shall be submitted in Single stage.
- b) **Envelope** shall contain EMD, documents in support of qualifying requirement duly signed and Price Bid.
- c) Envelope shall be sealed and super-scribed as "Construction of temporary security fencing around Colony Area, Tato-II HEP, Arunachal Pradesh".
- d) The Bidder shall seal the envelopes and address it to the officer who has invited the Tender under reference.

- e) The envelope shall bear the Name & Identification no. of the contract as defined in the NIB.
 - f) Any bid received after the due date and time of submission will be rejected. The bidders are therefore requested to ensure, in their own interest that the bids are delivered in time. NEEPCO shall not be responsible for any delay in postal or courier services or loss of any documents.
 - g) In addition to the above, the envelope shall indicate the name and address of the bidder to enable the bid to be returned unopened in case it is declared late in pursuant to sub-clause (f) above or otherwise.
 - h) If the envelopes are not sealed and marked as above, the Corporation will assume no responsibility for the misplacement or premature opening of the bid.
 - i) All pages and any corrections, if any, in the Bids shall be signed by the Bidder.
15. **Bid validity:** 90 (Ninety) days from the date of opening of Bids.
16. **Basis of Offer:**
- a) Bidder shall quote prices in INR. The price quoted should be inclusive of all taxes and duties etc. as may be applicable for complete scope of works as indicated in **Form-1 (BOQ)**.
 - b) The price quoted by the bidders shall be on firm basis. No escalation for any reason whatsoever shall be allowed over and above the bid price.
 - c) The Bidder shall quote prices taking into consideration of the complete scope of work, any item left out and not specifically mentioned but are required for completion of the work shall be carried out by the bidder without any additional cost to NEEPCO.

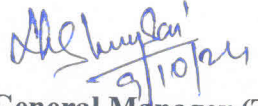

18. Contract Agreement:

- a) In the event of award, the selected firm will be required to enter in to a Contract Agreement with the NEEPCO within 7 (seven) working days from the date of the Letter of Award (LOA) or within such extended time, as may be granted by the NEEPCO.
 - b) Formal Contract Agreement will be executed on Non-judicial stamp paper of Rs. 100/- (Rs. one hundred only) as per the format provided by NEEPCO. Two sets of Non-Judicial Stamp papers of Rs.100/- each shall be purchased by the selected FIRM.
 - c) Till the time a 'Contract Agreement' is prepared and executed, the Letter of Award shall be read in conjunction with the Bidding Documents and will constitute a binding contract.
19. The selected Firm shall keep NEEPCO, both during and after the term of this Contract, fully and effectively indemnified against all losses, damage, injuries, deaths, expenses, actions, proceedings, demands, costs and claims, including, but not limited to, legal fees and expenses, suffered by NEEPCO or any Third Party, where such loss, damage, injury or death is the result of a wrongful action, negligence or breach of contract by the selected Firm, or its personnel.
20. NEEPCO shall not entertain any claim of any nature, whatsoever, including without limitations, any claim of expenses in relation to the preparation, submission or any other activity relating to bidding or any other expense till award of contract.
21. Submission of bids shall not automatically construe qualification for evaluation. NEEPCO reserves the right to reject any or all bids, or to annul the bidding process and reject all the bids for any justified and genuine grounds without thereby incurring any liability to the affected bidders, nor does it have any obligation to inform the bidders of the ground for the action of NEEPCO.
