The bidder must have submitted along with Techno-commercial bid i.e. the copy of past experience of works (as mentioned above) executed with completion certificate in any State Govt. / Central Govt. /PSU. Otherwise, the bid shall not be considered to any intending firm(s)/ contractors and bid will be rejected and their bid will be considered as disqualified bid.
