NAME OF WORK: Construction of Room for SWAS (System) of Boiler # 1 & Boiler# 2 at Plant area of AGBPS, NEEPCO Ltd., Bokuloni, Dist. Dibrugarh, Assam.

1. North Eastern Electric Power Corporation Limited, invites tender from prospective bidders fulfilling the Qualifying Requirement for carrying out the work **Construction of Room for SWAS (System) of Boiler # 1 & Boiler# 2 at Plant area of AGBPS, NEEPCO Ltd., Bokuloni, Dist. Dibrugarh, Assam.** at estimated cost of **Rs.1,56,382.00** only (including applicable GST).

2. SCOPE OF WORK:

The Scope of work under this tender covers the following:

Construction of Room for SWAS (System) of Boiler # 1 & Boiler# 2 at Plant area of AGBPS, NEEPCO Ltd., Bokuloni, Dist. Dibrugarh, Assam.

Please refer (Bill of Quantities) of Bid Document for detailed Scope of work.

3. TIME OF COMPLETION:

The schedule time of completion of the work shall be **45 (Forty-five) days** from the date of issue of work order.

4. BID FEE:

For participation in this tender, Bidders shall have to pay Bid Fee (non-refundable) of Rs. 224.00 (Rupees Two hundred & twenty-four only) inclusive of 12% GST. Applicable bank charges shall be borne by the bidder.

The bidder shall make the payment of Bid Fee through "SB Collect" in to Neepeco, State Bank of India Account drawn in favour of "NEEPCO Ltd., AGBP, Bokuloni Chariali Branch, Dist. Dibrugarh, Assam as per procedure / steps elaborated below Clause **No.5.1.**

The bidders registered as Micro/ Small Enterprises are exempted from paying applicable Bid Fee), subject to submission of requisite Certificate.

5. EARNEST MONEY DEPOSIT (EMD):

EARNEST MONEY DEPOSIT shall be Rs.3,000.00 (Rupees Three thousand) only.

3.	Read Accept the terms & condition and proceed
4.	Select "Assam" against State of Corporation
5.	Select "PSU" against type of Corporation & go to NORTH EASTERN ELECTRIC POWER CORPORATION LTD" then submit
6.	Select "AGBP parties" & submit
7.	Feed Necessary information in the appropriate boxes
8.	Payment through "Internet Banking" SBI Branch, SBI Buddy or Card Payment etc.
9.	Print Copies of receipt and submit

6. QUALIFYING REQUIREMENTS:

6.1 General Qualifying Requirement

The bidders shall furnish the copies of the following valid Registration Certificates with Techno-commercial Bid:

- (i) Valid GST Registration Certificate.
- (ii) PAN (Permanent Account Number) for Income Tax,
- (iii) Valid Solvency Certificate from any Nationalized Bank.
- (iv) Valid Trade License

6.2 Technical Qualifying Requirement:

The Bidder (Individual Company/Firm) should have successfully completed "similar works" for one of the following during the last 7 (seven) years, prior to publication of NIB.

- i) One similar completed work costing not less than the amount equal to 80% of the estimated cost.

OR

- ii) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

OR

- iii) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

Similar works are defined as "Construction/Repairing/Maintenance of Building works including structural steel works etc. executed under State Govt/Central Govt./PSU"

Documentary evidence in support of the above experience shall be furnished along with the bids for establishing eligibility. The documents should be in the form of copies of Work Order and Completion Certificate of Clients / Owners issued from Government / PSUs. Bids submitted without fulfilling the qualifying requirements shall be outright rejected.

These above-mentioned documents shall be submitted by hand, addressed to GM(C), CWC, NEEPCO Ltd., Bokuloni, Dist. Dibrugarh, Assam within the scheduled date and time mentioned under Clause 7 below.

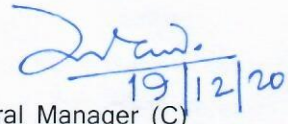
