## **Notice Inviting Tender**

The undersigned on the behalf of North Eastern Electric Power Corporation Ltd. (NEEPCO), a Public Sector Enterprises under the Ministry of Power, Govt. of India invites sealed tender with minimum 180 (One hundred Eighty) days validity from eligible bidders for execution of the following work. Terms & conditions are detailed here in under:

**1. Name of the work**: Transportation of repairable Labyrinth, Sealing Rings, Operating and Maintenance Seals and Transportation of repairable Runner from Dikrong Power House, PLHPS, Hoj, A.P. to M/s BHEL, Piplani, Bhopal, M.P.

### 2. Scope of the Work: -

The Scope of Works under this contract shall include transportation of (i) repairable Labyrinth, Sealing Rings, Operation and Maintenance Seals and (ii) repairable Runner from Dikrong Power House, PLHPS, NEEPCO Ltd., Hoj, A.P. to M/s BHEL, Bhopal, Piplani, Madhya Pradesh including any interim handling. The consignment shall be transported by 2(two) different vehicles without any transshipment. Packing & Loading of repairable Labyrinth, Sealing Rings, Operating and Maintenance Seals and loading of the repairable Runner at Dikrong Power House site, Hoj, A.P. and Unloading of the materials at BHEL, Piplani, Bhopal, Madhya Pradesh will be done by the Transporter.

#### **TERMS & CONDITIONS**

- A. Rates: The bidder should quote their price legibly with ink both in figures & words. In case of discrepancy arises in figure and words, the price written in words shall be considered for purpose. The Rates of the items should be indicated clearly in figure & words without over writing. In case of any correction/overwriting the same should be duly signed by the bidder.
- B. **Estimated Value:** ₹ 8,45,000.00 (INR Eight lacs forty five thousand) only excluding GST.
- C. **Taxes & Duties**: Taxes and duties, if applicable, should be indicated clearly.
- D. **Price Basis**: The rates for Taxes & Duties, if any, should be separately and clearly indicated in the Bid. The rate shall be indicated both in figures and in words. The price shall remain firm till completion of the job.
- E. **BID Security/Earnest Money Deposit:** Earnest Money @ 2% i.e. ₹ **16,900.00** (Rupees Sixteen Thousand Nine hundred) only for General Contractors/Firm @ 1% i.e. ₹ **8,450.00**

- (i) EMD submitted by successful bidder shall be retained as security deposit towards satisfactory execution of the order and will be released only after successful completion of the work to the satisfaction of the Corporation. If successful bidder fails to execute the order then EMD shall be forfeited by Corporation.
- (ii) EMD of all unsuccessful bidders will be returned only after finalization of the bid.
- (iii) Following units are however, exempted from payment of EMD:
  - a) Public Sector Enterprises.
  - b) Units registered with National Small Industries Corporation (NSIC) subject to:
    - The unit being registered with NSIC for the item tendered.
    - Registration certificate being valid as on date of Bid.
    - MSME Registered firm.

As the case may be, the bidders must submit proof to show that they are PSE or a valid NSIC Registration Certificate.

- F. **Payment:** 100% (hundred percent) payment shall be made after successful dropping of the consignment at the works of M/s BHEL, Piplani, Bhopal, M.P. The bidders are requested to submit the following details along with the bid documents for effecting e-payment.
  - a) Name & complete address of the firm as per bank record.
  - b) Complete address of the Bank with Branch details.
  - c) Type of Bank Account (Saving/Current/Cash Credit).
  - d) Core Banking Account Number

  - f) Permanent Account Number (PAN) under Income Tax.
  - g) GST Number (for supply of Goods and services) as applicable.

- G. **Period of Transportation:** The vehicle must be placed to the lifting point in minimum possible time of 2-3 days preferably within 1(one) week from the date of issue of the order and transportation shall be completed within reasonable time i.e., within one month from the date of dispatch from the lifting points.

H. **Lifting Point:** Repairable Runner and Labyrinth, Sealing Rings, Operating and Maintenance Seals should be lifted from Dikrong Power House site, PLHPS, NEEPCO Ltd., Hoj, Dist-Papumpare, Arunachal Pradesh - 791112.

#### 3. Qualifying Requirement:

The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirements along with the bid document submitted.

- **7.** The bidders should sign and stamp each and every page of the tender document & supporting documents submitted with the bid in support of acceptance of terms & conditions. The supporting documents should be serially numbered and total number of pages submitted, should be indicated in the covering letter.
- **8.** Exemptions for MSME's shall be applicable under the Govt. of India norms under PPC guidelines. Copy of valid MSME certificate in the relevant filed must be enclosed along with the bid to avail the MSME exemptions.
- **9.** The price preference as per Govt of India Guide Line shall be provided to NSIC registered Micro & Small Enterprises (MSEs) for which bidder should submit the documentary evidence of the same.

- **10.** Securely Packing, Lifting, , Movement & Transportation of repairable Labyrinth, Sealing Rings, Operating and Maintenance Seals and Runner from Dikrong Power House Site, Hoj and Unloading at Destination in BHEL, Piplani, Bhopal shall be in transporter's scope.
- **11.** The bidders should submit the following documents along with bid.
  - a) The valid National Permit for transportation/handling of heavy consignment.
  - b) The bidders shall have experience of executing similar types of work to any PSU / Govt. organization in last 2-3 years. In support of this, bidders should submit copy of such Work orders along with their Bid.
  - c) Bidder should submit self-attested copy of their Tax payer Identification Number, Tax/VAT Registration, Service Tax Registration, GST Registration and PAN Card as applicable.
- **12.Submission of Bid**: The Bid in sealed envelope shall be submitted to the office in person or by any authorized representative of the bidder or by means of registered post. Bid shall be submitted only under the bidder's letter head with details like complete address for communication, telephone/e-mail address/Fax No., name of contact person etc. so as to reach at this end on or before the due date.
