North Eastern Electric Power Corporation Limited (NEEPCO) invites single stage two envelope bids with 180 (one hundred eighty) days validity through online bidding system (e-tender) from reputed, experienced & resourceful contractors / firms/Suppliers for **hiring** of following types of vehicles at Tuirial Hydro Power Station (60MW), NEEPCO Ltd., Mizoram for a period of 3years.

Earnest Money/ Bid Security: NIL. However, Bidders are required to submit “**Bid Security Declaration**” accepting that if he/she/they withdraw or modify their bids during bid validity period or delay in placement of vehicle / executing the works if awarded, he/she/they will be suspended for a period of at least 2years in participating bids in future.

The bidders should have experience in supplying vehicles to PSU / Central or State Govt. Department.

Submission of tender document shall invariably be accompanied by **Bid Security Declaration, Warranty Form & Declaration**. Copy of PAN Card, GST Registration, Income Tax Exemption Certificate (for ST), documents in support of qualifying requirements, etc are to be submitted along with the Detailed Tender Document.

This tender is being processed through e-tendering/ e-procurement system. The bidding documents are to be downloaded from <https://etenders.gov.in> and bids are to be submitted / uploaded through above e-tendering system. Guidelines for e-tendering system are available on e-tender portal.

REGISTRATION FOR PARTICIPATION IN BIDS:

Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: <https://etenders.gov.in/eprocure/app>) by clicking on the link “**Online bidder Enrolment**” on the CPP Portal which is free of charge.

As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.

Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.

Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra, etc.), with their profile.

Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.

Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC/e-Token.

All the bidders are requested to get themselves registered well in advance and no extra time will be considered for submission of bids for the delay in on-line Bidder Registration, if any.

SUBMISSION AND OPENING OF BIDS:

Bidders shall prepare and submit their bids online in <https://etenders.gov.in>. Online bidding forms will be available in the above website. Detailed Bid document can be downloaded from this website after vendor registration. In the online Bid submission, Bidders will submit their Bids using their digital signature.

Submission of online bid is mandatory.

Bidders may view the tender opening results in <https://etenders.gov.in> by marking their presence for online tender opening.

Bidders are requested to visit <https://etenders.gov.in> and <https://www.neepco.co.in> regularly for any modification/clarification of the detailed bid document.
