3. **Bidding Procedure:**
The Bidder shall submit Bids under Single-Stage Single-Envelope bidding system through online. The Single Envelope shall contain all the documents such as Tender Forms & Data Sheets and Price Bid.
4. **Time of Completion:**
The scheduled Time for Completion of Works shall be 30 (Thirty) days reckoned from the date of issue of Letter of Acceptance or handing over of site by the Employer, whichever is later.
The bidders shall submit a construction programme considering Equipment planning, and mobilization of other resources so as to complete the Works within the stipulated Time for Completion.
5. **Earnest Money Deposit/ Bid Security:**
Earnest Money Deposit shall be Rs. 1,46,930.00 (Rupees One Lakh Forty-Six thousand, Nine Hundred and Thirty) only.
For bonafide Arunachal Pradesh Schedule Tribe (APST), EMD shall be Rs. 73,465.00 (Rupees Seventy-Three Thousand, Four Hundred and Sixty-Five) only. The APST bidders shall submit Schedule Tribe

Certificate issued by the competent authority along with their bid. The EMD shall be paid /deposited as per procedure given in Part-2 of Bid Document. Bids without or insufficient EMD shall be rejected.

6. Qualifying Requirements of Bidders:

Online limited bids for the instant work have been invited in CPP portal from 5(five) enlisted bidders as indicated in Short NIB, who are bonafide residents of Arunachal Pradesh.

8. **This tender is conducted for procurement of works. Therefore, the benefits admissible to MSE bidders in terms of Public Procurement Policy (for MSEs)-2012 including EMD exemption, purchase preference etc. shall not apply.**
