North Eastern Electric Power Corporation Limited (NEEPCO/ the Company/the Corporation), a leading Miniratna Category-I Central Public Sector Enterprise under the Ministry of Power, Government of India and a wholly owned subsidiary of NTPC Ltd, invites online electronic bids in the e-tender portal https://etenders.gov.in from prospective bidders fulfilling the Qualifying Requirement under Single-Stage Single-Envelope bidding system through Domestic Competitive Bidding (DCB) route for "Empanelment of cost Auditors in NEEPCO for the Financial Year 2025-26, 2026-27 and 2027-28".

1. Scope of Services

Detailed scope of work shall be as under:

- 1.1 To Carry out Cost Audit of the Power Stations of the Company as detailed in Clause-2, Section II Information for Bidders, in accordance with the provisions of Section 148 of the Companies Act, 2013 and the Companies (Cost Records and Audit) Rules 2014 & amendments thereto. Cost Audit shall be in adherence to the relevant orders/clarification issued by Cost Audit Branch, Ministry of Corporate Affairs, Govt. of India and the Cost Accounting Standards issued by the Institute of Cost Accountants of India from time to time.
- 1.2 Scope of works include consolidation of the Cost Audit Reports & annexure to cost audit reports of all power stations, conversion of Consolidated Cost Audit Reports in XBRL mode, filling the same with Central Government and other associated works.
- 1.3 Compliance with all notifications/instructions issued in respect of cost audit under the Companies Act 2013.
- 1.4 Attending meetings (including Audit Committee and Board of Directors meeting) of the Company for matters relating to Cost Audit & Reports thereon.
- 1.5 Cost Audit firm so appointed shall commence cost audit of the power stations and submit reports thereon along with reservation or qualification or observations or suggestion, if any, in form CRA 3 and annexures as per notification or any other instruction issued by Central Government from time to time or any other section of the Companies Act 2013.

2. Bidding Procedure:

The Bidder shall submit online bids under Single-Stage Single-Envelope bidding system.

3. Duration of Appointment

3.1 Based on the evaluation of the bids, NEEPCO shall empanel 05 (five) no. highest ranked firms of Cost Accountants, as per qualifying criteria (marking system indicated at Annexure-I under Clause 6.3(v) Section – III below) in order of the total marks obtained by the firms in descending order (i.e., H1 to H5). The qualified firm will be empanelled for a period of 03 (three) years from the FY 2025-26. However, NEEPCO will appoint one firm (ranked highest, i.e., H1) only for a FY as the Cost Auditor of the Company, subjected to approval of the appropriate authority. In case the H1 empanelled firm is not eligible for such appointment or not accepted the offer, the next highest ranked firm will be given the offer. Such appointment will be given to the eligible Cost Audit Firm on year to year basis as per the agreed terms & conditions, subject to the satisfactory performance and approval of the appropriate authority.

4. Qualifying Requirements

4.1 General Qualifying Requirements

- i) A bidder shall be a registered entity in India.
- ii) The individual or the firm, as the case may be, is eligible for appointment under the Companies Act 2013, the Cost and Works Accountants Act, 1959 & amendments thereto and the rules/ regulations made there under.
- iii) The cost audit firm(s) is free from any disqualification under sub-section (3) or sub-section (4) of section 141 read with sub-section (5) of section 148 of the Companies Act, 2013. to this, the cost audit firm(s) must not be holding any assignment of Statutory Auditor or Internal Audit or physical Verification of NEEPCO as on the date of appointment and during the continuity of the Cost Audit
- iv) The individual or the firm, as the case may be, satisfies the criteria provided in section 141 of the Companies Act 2013, so far as may be applicable.
- v) The proposed appointment is within the limits laid down by or under the authority of the Companies Act 2013.

5. Bids by Consortium /Joint-Venture Companies:

Formation of Consortium /Joint-Venture for participation in the tender is not allowed.

6.1 E-Tendering / E-Procurement:

This tender is being processed through e-tendering/e-procurement system. The bidding documents are to be downloaded from https://etenders.gov.in and bids are to be submitted/uploaded through above e-tendering system. Guidelines for e- tendering system are available on e- tender portal.

6.2 Registration for Participation in Bids


- (a) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://etenders.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- (b) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- (c) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- (d) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- (e) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- Bidder can then log in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.


