The undersigned on the behalf of "North Eastern Electric Power Corporation Ltd (NEEPCO)", a Public Sector Enterprises under the Ministry of Power, Govt. of India invites sealed tender with minimum 180 (One hundred Eighty) days validity from PLHPS-NEEPCO registered contractors of Hoj for execution of the following work. Terms & conditions are detailed here in under:

1. **Name of the work:** Engagement of Manpower in different categories for day to day upkeeping of Power House, DATA Entry at P.H. Store & ERP, Driving of Water Mist Fire Tender of Dikrong Power House, Hoj, Operation of 3x625 kVA DG set installed at Diesel Power House site, 43Km. Yazali and Operation of 2x625kVA DG set installed at Dikrong Power House at Hoj, PLHPS, A.P.
2. **Scope of the Work:** -The scope of work under this contract shall include engagement of labourers on man-days basis as below:
 - A) **Skilled labour 14 (Fourteen) Nos.** 2(Two) Nos of labourer to be engaged in DATA Entry for ERP, 1(One) No. labourer to be engaged in DATA Entry at P.H. Store, 1(One) No. labourer to be engaged for driving of Water Mist Fire Tender, 7(Seven) Nos. labourers to be engaged for operation of 3x625 kVA DG set installed at Diesel Power House site, 43KM, A.P. and 3(Three) Nos. labourers to be engaged for operation of 2x625 kVA DG set installed at Dikrong Power House, Hoj, A.P.
 - B) **Semi-skilled 13(Thirteen) Nos.** 11(Eleven) Nos. labourers to be engaged in day to day upkeeping of P.H., Switchyards & adjoining area, Hoj, 1(one) No labour for operation of 2x625 kVA DG set installed at Dikrong Power House site, Hoj, A.P. and 1(one) No. labourer to be engaged for operation of 3x625 kVA DG Set installed at Diesel Power House site, 43Km., Hoj, A.P.
 - C) **Un-skilled 4(Four) Nos :** 4(Four) Nos labourers to be engaged for day to day upkeeping of Power House, Hoj.
3. **Rate per unit basis:**
 - 3.1. Rate for the scope of work of respective item against specification shall be "FIRM" till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
 - 3.2. Bidders are to quote unit rates in figures and words for the items indicated in **Annexure-I** of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail, and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over writing, changes and cuttings shall be initialed by the bidders.

3.3. **Taxes, Duties & Levies:** Bidders shall quote their rates against respective item specification inclusive of all taxes. No extra charge on this account shall be paid by the Corporation.

4. **Estimated Amount:**

4.1. ₹ 62,80,675.00 (Rupees Sixty Two Lakhs Eighty Thousand Six Hundred Seventy Five) only.

4.2. GST, and other taxes & charges as applicable will be deducted from work value.

5. **Payment Terms:**

5.1 Monthly payment will be released for supply of man-days per month. The supply bill (in triplicate) along with attendance statement and labour payment statement to be submitted to the Senior Manager (E/M)-I, PH & SY (TGA), PLHPS, NEEPCO Ltd. Hoj, by the contractor on the 1st working day of following month for release of payment. The contractor shall also submit a list of labours engage indicating their name & wages for effecting necessary payment. Deduction of TDS as may be applicable shall be deducted from the bill in terms of Income Tax Act. In order to ensure the actual benefit reaches to the worker, the contractor shall remit the actual amount to be paid to the worker every month for which contractor shall produce bank debit Vouchers or documents of previous month for releasing the bill of current month.

6. **Paying Authority:** The paying authority shall be Manager (F), PLHPS, Yazali (A.P).

7. **Period of Supply:** The Period of supply shall be for 6(six) months i.e. from **01/10/2023 to 31/03/2024**.

8. **Labours Rules and Regulation:** Compliance of statutory labour rules, regulation, acts and amendments as notified by the Govt. of India and State Govt. Shall be the responsibilities of contractor.

9. **Employees Provident Fund Scheme:** Strict adherence to all statutory labour rules, regulations, EPF & MP Act and as amended from time to time by the government of India and State government should be complied by the contractor. The Corporation shall effect recovery of 25% of labour wages against each running (monthly) bill as well as final bill of any amount as may be prescribed from time to time if the contractor fails to comply with the provision of the said Act.

10. **Medical Facilities/ Insurance:** For successful bidder, all the contract labour shall be provided with basic medical facilities and the medical insurance coverage shall be done by the contractor for a maximum coverage of Rs 2.00 lakhs (Rupees two Lakhs) per head/per annum. The insurance is to be done from any Govt. Insurance Company. The insurance policy against each worker shall have to submit along with the bill every month to ensure the validity of the insurance policy. The premium paid shall be reimbursed by NEEPCO at actual either equated monthly premium or annually.


14. Terms & Condition for Submission of Tender:
