Dear Sir,

The undersigned on behalf of "North Eastern Electric Power Corporation" (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) For maintaining a hygiene environment and fulfilling the prime requirement of ISO, the work is to be carried out through the capable and resourceful Contractor, as well as having and doing a similar nature of works and experience, preferably PLHPS registered contractor for execution of the following work. Terms & conditions are detailed herein under:

1. **Name of the work:** "Upkeep of PLHPS Dam road from Pitapool to Thou Nallah Ch. 0.00km to C 3.34.00km (Ch. 0.0 at junction of Ziro-Kimin road), PLHPS Yazali, Arunachal Pradesh from "1 st Ju 2023 to 31 st March 2024."
2. **Scope of the Work:** - The work to be executed as per Technical Specification attached in the tender document and as mentioned in the schedule of item enclosed in the tender document. Moreover, instruction of Site-Engineer is final and binding.
3. **Rate per unit basis:**
 - 3.1. Rate against each item shall be "FIRM" till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
 - 3.2. Bidders are to quote unit rates in figures and words for the items indicated in **Annexure-I** of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over writing, changes and cuttings shall be initialed by the bidders.
 - 3.3. **Taxes, Duties & Levies:** Bidders shall quote their rates against respective item specification inclusive of all taxes including GST, Building Cess and all charges etc. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work.
4. **Estimated Amount:**
 4. **Rs. 12,16,132.00** (Rupees Twelve Lakhs Sixteen Thousand One Hundred Thirty-Two)
 - 4.2 Building Cess, GST and other taxes & charges as applicable will be deducted from work value.
5. **Payment Terms:**
 - 5.1 Payment will be released after satisfactory completion of work as certified by the Engineer-In-Charge.
 - 5.2 The payment shall be made monthly basis under e-payment system. No extra payment shall be made by the corporation.
6. **Paying Authority:** The paying authority shall be **Manager (F)**, PLHPS, Yazali (A.P).
7. **Time of Completion:** The period of Contract shall be from/w.e.f **1st July, 2023 to 31st March, 2024.**
8. **Labour Act and regulation:** - Strict adherence to all statutory labour rules, regulations, EPF Acts & amendments by the Govt. of India and state Govt. and should be complied by the contractor.
9. **Employee provident scheme:** - The contractor himself will be responsible for compliance of the provisions of the said act. As per Govt. notification. The Contractor must be a registered establishment under the EPF & MP act 1952 and scheme there under and shall specify Independent Code No.

10. General Safety: - All necessary /adequate personal safety measures/requirements as per relevant safety engineering and safety code shall be kept available at site. The contractor shall ensure proper use of the safety measure.

11. General Insurance:- The contractor shall be fully responsible for introducing provision against Insurance of laborer's and materials to be engaged at site.

12. Compensation for Delay:

In case of delay in work of items within the stipulated period indicated in **clause no.7** above, compensation for delay at the rate of 0.5% (Zero point five percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of 10% (Ten percent) of the contract price.

13. Security Deposit: The nature of the work is such that there shall be no security deposit.

14. Exemption for MSME registration Firms: exemption for MSME's shall be applicable under the Govt. of India norms under PPC guidelines.

15. Earnest Money Deposit:

Earnest Money Rs. **30,403.00** (Rupees Thirty thousand Four hundred Three) only for General Contractors/Firm & Rs. **12,161.00** (Rupees Twelve thousand One hundred Sixty-One) only for SC/ST contractor shall be **submitted through SBI Collect**. Further, Non-submission of EMD, wherever applicable, shall result in cancellation of the bid document. However, firms/contractors registered in NEEPCO are exempted from submitting of earnest money along with tender in their respective class of registration with MSME Certificate.

16. Payment for online EMD through SBI Collect

STEP-3	Click to accept terms & condition and then click on "proceed to continue further"
STEP-4	Click Arunachal Pradesh in the drop down menu. Thereafter select "PSU-Public Sector Undertaking" then click on "Go"
STEP-5	Select "NORTH EASTERN ELECTRIC POWER CORPORATION" and click on "Submit"
STEP-6	Select "RHEP-PARTIES" in the drop down menu
STEP-7	Fill up the details a) Name b) In Short details write EMD/Tender Cost NIT No. (As applicable) c) Choose Vendor Click on "Submit to continue."
STEP-8	This screen shall lead to payment gateway from where SBI and other banks, Debit/ Credit Card and wallet etc. may be chosen by the vendor
STEP-9	After completion of the process a copy of the payment e-receipt may be taken and to be completed in the EMD/Tender cost attachment of the online bid.

17. Submission of Documents:-

 - ii) Certified copy of registration with PLHPS, NEEPCO, Yazali (A.P) in case of PLHPS registered contractor.

 - iv) Copy of latest GST return submitted.

- b) Successful bidder has to submit the Certified copy of EPF registration under EPF&MP Act, 1952 with code number to capacitate for issuing of work order.
- c) Successful bidder will have to submit the following documents along with the final bill / Invoice for effecting e-payment.
 - i) Name & complete address of your firm as per Bank record.
 - ii) Complete address of the Bank with branch details.
 - iii) Type of Bank account (Saving/current/Cash credit).
 - iv) Bank account number (indicating core Banking account number), if any.
 - v) IFS Code (11 digit)/MICR code as applicable.
- i) E-mail address of the vendor/authorized official along with mobile number (for receiving the update status of payment) if any.
