The undersigned on behalf of "North Eastern Electric Power Corporation" (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) from experienced/reputed/preferably PLHPS registered contractors for execution of the following work. Terms & conditions are detailed herein under:

- 1. Name of the work: "Supply and engagement of 3(three) nos. of Skilled labours for monitoring of reservoir rim & intake water level at PLHPS, 41km, Arunachal Pradesh"
- 2. Scope of the Work: The work to be executed as per Technical Specification attached in the tender document and as mentioned in the schedule of item enclosed in the tender document. Moreover, instruction of Site-Engineer is final and binding.

3. Rate per unit basis:

- 3.1.Rate against each item shall be "FIRM" till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
- 3.2.Bidders are to quote unit rates in figures and words for the items indicated in Annexure-I of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over writing, changes and cuttings shall be initialed by the bidders.
- 3.3. Taxes, Duties & Levies: Bidders shall quote their rates against respective item specification inclusive of all taxes including GST, Building Cess and all charges etc. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work.

4. Estimated Amount:

- 4.1 Rs. 6,87,381.00 (Rupees Six lakh eighty-seven thousand three hundred and eighty-one) only.
- 4.2 Building Cess, GST and other taxes & charges as applicable will be deducted from work value.

5. Payment Terms:

5.1 Payment will be released after satisfactory completion of work as certified by the Engineer-In-Charge. No part payment/advance payment will be entertained.

5.2 100% Payment will be released on successful completion of the work on monthly basis. In of any defect in the work detected after the completion of the work within the defect liable period, shall be made good by the contractor at his own risk and cost, and no extra payment shall be made by the corporation.

6. Paying Authority: The paying authority shall be the Manager (F), PLHPS, Yazali (A.P).

- 7. Engineer-In-Charge: The Engineer in charge shall be the Deputy General Manager(C), HS(M), NEEPCO. Limited PLHPS, 43km Yazali.
- 8. Period of the work: The work shall be Started from 01.10.2023 to 31.03.2024.
- 9. Compensation for Delay: Nil
- 10. Defect Liability Period: The nature of work is such that there is no liability period.
- 11. Security Deposit: Nil.

12. Earnest Money Deposit :

Earnest money Rs 17,184.00. (Rupees Seventeen Thousand One Hundred Eighty-Four) only for general contractors/firm & 6,874.00 (Rupees Six Thousand Eight Hundred Seventy -Four) only for SC/St contractor shall be submitted in the form of Bankers cheque/Demand Draft duly pledged in favour of NEEPCO Ltd, Yazali ,Lower Subansiri, Arunachal Pradesh. Our banker is S.B.I. ,Yazali 9917.PLHPS,non-submission of EMD ,wherever applicable , shall result in cancellation of the bid document. However, firms/contractors registered in NEEPCO are exempted from submitting of earnest money along with tender in their respective class of registration.
