Dear Sir,

The undersigned on behalf of “North Eastern Electric Power Corporation” (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) from experienced/reputed/preferably PLHPS registered contractors for execution of the following work. Terms & conditions are detailed herein under:

1. **Name of the work:** “Repairing and renovation of quarters no. C-23 and C-24, along with construction of new septic tank and periphery development works at 43km NEEPCO colony, RHPS, A. P.”

2. **Scope of the Work:** - The work to be executed as per Technical Specification attached in the tender document and as mentioned in the schedule of item enclosed in the tender document. Moreover, instruction of Site-Engineer is final and binding.
3. **Rate per unit basis:**
- 3.1. Rate against each item shall be "FIRM" till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
- 3.2. Bidders are to quote unit rates in figures and words for the items indicated in **Annexure-I** of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over writing, changes and cuttings shall be initialed by the bidders.
- 3.3. **Taxes, Duties & Levies:** Bidders shall quote their rates against respective item specification inclusive of all taxes including GST, Building Cess and all charges etc. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work.
4. **Estimated Amount:**
- 4.1 **Rs. 13,73,236.00** lakhs (Rupees Thirteen Lakhs Seventy-Three Thousand Two Hundred Thirty-Six) only
- 4.2 Building Cess, GST and other taxes & charges as applicable will be deducted from work value.
5. **Payment Terms:**
- 5.1 Payment will be released after satisfactory completion of work as certified by the Engineer-In-Charge. No part payment/advance payment will be entertained.
- 5.2 **90%** Payment will be released on successful completion of the work. Balance **10%** will be kept as Security deposit, which will be released after expiry of defect liability period for the Work. In case of any defect in the work detected after the completion of the work within the defect liability period, shall be made good by the contractor at his own risk and cost, and no extra payment shall be made by the corporation.
6. **Paying Authority:** The paying authority shall be the **Manager (F)**, PLHPS, Yazali (A.P).
7. **Engineer-In-Charge:** The Engineer in charge shall be the **Senior Manager(C)**, R&B(M), NEPCO. Limited PLHPS, 43km Yazali.
8. **Time of Completion:** The work shall be completed within **3(Three) Months** from the date of issue of the Work Order.
9. **Compensation for Delay:**
In case of delay in work of items within the stipulated period indicated in **clause no.8** above, compensation for delay at the rate of 0.5% (zero point five percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of **10% (Ten percent)** of the contract price.
10. **Defect Liability Period:**
The works shall be subjected to a defect liability period of **1(one) year** from the date of completion of work in all respect. The nature and extent of defects to be considered for the purpose of Defect Liability, shall be decided by the Head of Project/Engineer-In-Charge and decision of Head of Project/Engineer-In-Charge in this matter shall be final and binding. On expiry of defect liability period a Certificate in this regard shall be issued by the Engineer-in-charge. In case of non-compliance of clause, no 5.2 the security deposit shall be forfeited.
11. **Security Deposit:**

10% (Three percent) of the work value shall be retained as security deposit and the same shall be released after expiry of defect liability period or defect rectification work if any arises whichever is later.

12. Earnest Money Deposit :

Earnest money Rs **34,331.00**. (Rupees Thirty-Four Thousand Three Thirty-One) only for general contractors/firm & **13,732.00** (Rupees Thirteen Thousand Seven Hundred Thirty-Two) only for SC/St contractor shall be submitted in the form of Bankers cheque/Demand Draft duly pledged in favour of NEEPCO Ltd, Yazali ,Lower Subansiri, Arunachal Pradesh. Our banker is S.B.I. ,Yazali 9917.PLHPS,non-submission of EMD ,wherever applicable , shall result in cancellation of the bid document. However, firms/contractors registered in NEEPCO are exempted from submitting of earnest money along with tender in their respective class of registration.

13. Submission of Documents:-

- a) The following documents are to be submitted along with the bid document.
 - i) Copy of Income Tax PAN card.
 - ii) Certified copy of registration with PLHPS, NEEPCO, Yazali (A.P) in case of PLHPS registered contractor.
 - iii) Copy of Goods and Service Tax (GST) registration.
 - iv) Copy of latest GST return submitted.
- b) Successful bidder has to submit the Certified copy of EPF registration under EPF&MP Act, 1952 with code number to capacitate for issuing of work order.
- c) Successful bidder will have to submit the following documents along with the final bill / Invoice for effecting e-payment.
 - i) Name & complete address of your firm as per Bank record.
 - ii) Complete address of the Bank with branch details.
 - iii) Type of Bank account (Saving/current/Cash credit).
 - iv) Bank account number (indicating core Banking account number), if any.
 - v) IFS Code (11 digit)/MICR code as applicable.
- i) E-mail address of the vendor/authorized official along with mobile number (for receiving the update status of payment) if any.

14. Terms & Condition for Submission of Tender:

- (i) Non-transferable Bid documents can be obtained from the Office of the General Manager (C), PLHPS, NEEPCO, Yazali, Arunachal Pradesh from **10.07.2023 to 04.08.2023** in any working days between 11:00 hours to 13:00 hours.
- (ii) Last date of submission of bid: On **05.08.2023** up to **13:00** hours at office of the General Manager (C). PLHPS, NEEPCO. Limited, Yazali, A.P.
- (iii) Date of opening of bid: On **05.08.2023 at 15:00** hours in the office of the General Manager (C). PLHPS, NEEPCO. Limited, Yazali, A.P.
- (iv) Sealed Tender is to be submitted to the undersigned either in person or by speed post as per the following:
