The undersigned on behalf of "North Eastern Electric Power Corporation" (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) from Panyor Lower Hydro Power Station (PLHPS), NEEPCO registered contractors of Hoj for execution of the following work. Terms & conditions are detailed herein under:

- 1. Name of the work: "Improvement of Road Surface from Shiv Mandir to PMT A-7 and towards 132 KV, Dikrong Power House, Hoj."
- 2. Scope of the Work:-The work to be executed as per Technical Specification attached in the tender document and as mentioned in the schedule of items enclosed in the tender document.
- 3. Rate per unit basis:
- 3.1. Rate for the scope of work of respective item against specification shall be "FIRM" till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
- 3.2. Bidders are to quote unit rates in figures and words for the items indicated in Annexure-I of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over writing, changes and cuttings shall be initialed by the bidders.
- 3.3. Taxes, Duties & Levies: Bidders shall quote their rates against respective item specification inclusive of all taxes and Duties including Forest Royalty, GST, Building Cess etc. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work.
- 4. Estimated Amount:
- 4.1 ₹ 76,85,975.00 (Rupees Seventy-Six Lakhs Eighty-Five Thousand Nine Hundred Seventy-Five) only.
- 4.2 Building Cess, GST and other taxes & charges as applicable will be deducted from work value.
- 5. Payment Terms:
- 5.1 Payment (Running Interim/Final) will be released after satisfactory completion of work as certified by the Engineer-In-Charge. No part payment/advance payment will be entertained.
- 5.2 90 % Payment will be released on successful completion of the work. Balance 10% will be kept as Performance Guarantee/Security Deposit, which will be released after expiry of defect liability period for the Work. In case of any defect in the work detected after the completion of the work within the defect liability period, shall be made good by the contractor at his own risk and cost, and no extra payment shall be made by the corporation.
- 6. Paying Authority: The paying authority shall be Head of Finance, PLHPS, Yazali (A.P).
- 7. <u>Time of Completion</u>: The work shall be completed within 30 (Thirty) days from the date of issue of work order or handing over of site.

### 8. Compensation for Delay:

In case of delay in work of items within the stipulated period indicated in clause no.7 above, compensation for delay at the rate of 0.5%(Zero point five percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of 10%(Ten percent) of the contract price.

## 9. Defect Liability Period:

The works shall be subjected to a defect liability period of 12 (Twelve) months from the date of completion of work in all respect. The nature and extent of defects to be considered for the purpose of Defect Liability, shall be decided by the Head of Project/Engineer-In-Charge and decision of Head of Project/Engineer-In-Charge in this matter shall be final and binding. On expiry of defect liability period a Certificate in this regard shall be issued by the Engineer-in-charge. In case of non compliance of clause no 5.2 the security deposit shall be forfeited.

## 10. Security Deposit:

10% (Ten percent) of the work value shall be retained as security deposit and the same shall be released after expiry of defect liability period or defect rectification work if any arises whichever is later.

### 11. Earnest Money Deposit:

Earnest Money ₹ 1,53,719.50 (Rupees One Lakh Fifty-Three Thousand Seven Hundred Nineteen and Paise Fifty) only for General Contractors/Firm & ₹ 76,859.75 (Rupees Seventy-Six Thousand Eight Hundred Fifty-Nine and Paise Seventy-Five) only for SC/ST contractor shall be submitted through SB collect. Steps for SB collect.

STEP-5	Select "NORTH EASTERN ELECTRIC POWER CORPORATION" and click on submit
STEP-6	Select "RHEP-PARTIES" in the drop down menu
STEP-7	Fill up the details  a) Name  b) In short details write Tender Cost/EMD, NIT No.(As applicable)  c) Choose Vendor
STEP-8	Click on "submit" to continue  This screen shall lead to a payment gateway from where SBI and other banks, DEBIT/CREDIT card and wallet etc. may be chosen by the vendor.
STEP-9	After completion of the process, a copy of the payment e-receipt may be taken and to be uploaded in the Tender coast attachment of the online bid/attach to Bid document in offline bid.

## 12. Qualifying requirement:

- a) Technical Qualifying Requirement: The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirements along with the bid document submitted.
  - i) Copy of Income Tax PAN Card.
  - ii) Copy of Valid registration with PLHPS, NEEPCO Ltd., Yazali (A.P), Class-I(A) and above.
  - iii) Copy of Goods and Service Tax (GST) registration.
  - iv) Copy of latest GST return (GST-3B) submitted.
  - v) Earnest Money.
  - vi) Certified copy of EPF registration under EPF&MP Act, 1952 with code number.
  - vii) The bidder shall have experience of successful completion of like his work under this package either of the following in any Government/PSU/Municipal Corporation/Semi-Govt./Quasi

Govt. Organizations/Reputed Agencies (Subcontract) during last 5 (Five) years ending day of month before the one in which application is invited: To be substantiated by attested copies of completion certificate.

- a) One (1) similar completed works or work value costing not less than the amount equal to 80% of the estimated cost.
- b) Two (2) similar completed works or work value costing not less than the amount equal to 60% of the estimated cost.
- viii) Successful bidder has to submit the list of T & P's in their possessions.
- ix) Successful bidder will have to submit the following documents along the final bill/invoice for effecting e-payment.
